- B. Authorization to Advertise for Bids Regarding Policemen's and Firefighters' Retirement Fund and the Sewer Revenue Bonds. (164-10) (Rumpke)

  This request will authorize the advertisement for bids regarding taxable General Obligation Bonds in the amount of \$35.8 million for the Policemen's and Firefighters' Retirement Fund and nontaxable Sewer Revenue Bonds in the amount of \$14.4 million.p.14
- C. Authorization to Submit 2010 Consolidated Plan to the US Department of Housing and Urban Development (HUD), Accept Awards and Execute Subrecipient Agreements – FY2011. (165-10) (P. SUBJECT: Resolution to Authorize Advertisement for Bids for Pension Bonds

Authorization is requested to advertise for bids for \$35.8 million in taxable general obligation bonds for the Policemen's and Firefighters' Retirement Fund. This is the second issue of the planned series of bonds designed to address the underfunding. Annual debt service of approximately \$2.9 million will be budgeted in the 2010-2011 Budget and for the subsequent nineteen years. A companion ordinance and resolution are also requested to authorize this sale. Both the ordinance and the resolution are required documents for this bond sale.

In addition, we have an opportunity to refund the 2001A Sewer Bonds with new bonds at a favorable savings to the government. Authorization is requested to advertise for bids and companion ordinance and resolution for \$14.4 million in non-taxable sewer revenue bonds.

The U.S. Department of Housing and Urban Development (HUD) requires a consolidated application submission for jurisdictions receiving funds through HUD's Planning and Community Development programs. The purpose of the Consolidated Plan is to serve as the planning document for the Lexington-Fayette Urban County Government's participation in these programs. The overall goal of the programs is to develop viable urban communities by providing decent housing, a suitable living environment, and expanding economic opportunities for low and moderate income persons. The proposed 2010 Consolidated Plan includes a housing market needs analysis and a five-year strategic plan along with the jurisdiction's goals and objectives for addressing housing and community development needs five-year period from July 1, 2010 through June 30, 2015. The 2010 Consolidated Plan also includes a one-year action plan providing for the expenditure of Community Development Block Grant (CDBG) funds, HOME Investment Partnerships funds, and Emergency Shelter Grants (ESG) funds for Fiscal Year 2011 (the period of July 1, 2010 through June 30, 2011) to address some of the identified problems.

Federal regulations require that an active citizens' participation process be used to identify needs and to recommend the allocation of these federal resources. Two required public hearings have been conducted for the purpose of soliciting citizen comment on the housing and non-housing needs of the low-income population and on the budgeting of these federal funds to address identified needs. Applications for ESG, HOME, and CDBG funds were accepted through a uniform application process. Application solicitation was available through the LFUCG web page for the convenience of agencies having an interest in Consolidated Plan funding. The applications received were reviewed by the staff of the Division of Community Development. Their recommendations for funding were reviewed

by the Commissioner of Finance and Administration and the Senior Advisor to the Mayor. The proposed plan was made available for public comment as provided by the approved Citizens Participation Plan on March 8, 2010. The 30-day comment period expires on April 6, 2010. No substantial written comments on the draft plan have been received.

The Action Plan describes how funds available through the three program areas will be allocated and spent. The CDBG program has \$2,278,561 in federal funds with \$200,000 in program income anticipated in fiscal year 2011 for a total of \$2,478,561. The HOME Investment Partnerships program has \$1,501,092 in federal funds, with a required local cash match of \$327,746 requested from the 2011 general fund budget (\$163,750) and from the proceeds of a closed-out Urban Development Action Grant loan (\$163,996), and program income of \$250,000 for a total of \$2,078,838; and the Emergency Shelter Grants program has \$91,513 in federal funds, with a proposed FY 2011 general fund cash match of \$24,000, and an in-kind match of \$67,513 from subrecipient agencies.

These funds will be expended on public improvements, housing rehabilitation, public services, a first-time Homebuyer program, development of homeownership units for low-income households, development of rental units for low-income populations, homeless prevention activities, operational support for emergency and transitional housing, and planning and administration activities. A list of projects as recommended for the Community Development Block Grant program, the HOME program, the Emergency Shelter Grant program, and the American Dream Downpayment Initiative is attached.

Council authorization to submit the 2010 Consolidated Plan, with funding allocations as recommended herein, to accept the herein described federal funds, subject to the availability of sufficient funds in FY 2011, and to execute written agreements in accordance with the approved plan is hereby requested.

QUALITY UNDER THE KENTUCKY CLEAN DIESEL GRANT PROGRAM FOR RETROFIT OF REFUSE HAULERS

On January 14, 2010 (Resolution No. 7-2010), Council approved the submission of an application prepared by the Department of General Services requesting funding from the Kentucky Division for Air Quality under the Kentucky Clean Diesel Grant Program. Lexington-Fayette Urban County Government has been selected for full funding in the amount of \$150,000 for the purchase and installation of Diesel Multi-Stage Filters (DMFs) on 26 refuse haulers.

Funds will be used to retrofit 26 refuse haulers (2002-2006 models) each with a Diesel Multi-Stage Filter. The modifications will last from 7-15 years and will provide up to a 50% reduction in particulate matter per vehicle. Particulate matter is vehicle emissions comprised of a mixture of nitrogen oxides, sulfur oxides, metals, dust, and toxic chemicals.

No match is required. The Kentucky Division for Air Quality has been awarded these funds from the U.S. Environmental Protection Agency's State Clean Diesel Grant Program. The purpose of this program is to assist entities across Kentucky in building sustainable diesel emission reduction programs, ultimately protecting human health and the environment by achieving and maintaining acceptable air quality.

The purpose of this memorandum is to request approval of an agreement between LFUCG and the University of Kentucky for specialized water quality sampling and analysis within a defined area of the Wolf Run watershed.

Over the past 15 years, Dr. Gail Brion, Raymond-Blythe Professor and Director of the Environmental Research and Training Laboratories at UK, has developed a systematic approach to sampling and data analysis that identifies hot-spots of human fecal wastes in local streams and waterways. The Division of Water Quality is recommending approval of a pilot project to determine if past positive fecal coliform results in the Wolf Run watershed can be verified as human in origin.

The Division of Water Quality, along with citizens representing the Friends of Wolf Run will be partnering with UK researchers in implementing this pilot project in accordance with the enclosed Quality Assurance Project Plan (QAPP).

The total cost of the project is \$73,966 and funds for this project are budgeted in 4002-303401-3401-71299. Questions regarding this memorandum should be directed to Charles Martin at 425-2455.

All other similar objectionable or toxic substances shall be reviewed by the director, division of sanitary sewers, prior to any discharge into the public sewer. Upon the promulgation of the Federal Categorical Pretreatment Standards for a particular industrial subcategory, the Federal Standard, if more stringent than limitations imposed under this chapter for sources in that subcategory, shall immediately supersede the limitations imposed under this chapter.

In Fiscal Year 1998, the Lexington-Fayette Urban County Government's Family Care Center began a home visitation program for the purpose of addressing many of the limitations observed among existing prevention efforts aimed at low-income families, and to create a system of support more responsive to emerging social and familial realities. The Home Network provides home visitation services for high risk families from birth of the first child up to age two. This program is based upon evidence that home visitation programs are effective in reducing child abuse and neglect.

The Home Network program is being funded by the Kentucky Cabinet for Health and Family Services in a "pass-through" arrangement with the Lexington-Fayette County Health Department as the granting agency. The source of federal funds is the Kentucky Medical Assistance Program (Medicaid) and tobacco settlement dollars. The Kentucky Legislature has earmarked a portion of Kentucky's tobacco settlement dollars for funding of programs that will help the state reach the goal that all young children in Kentucky are healthy and safe, possess the foundation that will enable school and personal success, and live in strong families that are supported and strengthened by their communities.

The Home Network program is a "fee for service" program, in that the LFUCG only receives funding for services that it delivers. For 2011, the Kentucky Cabinet for Health and Family Services has estimated the following allocations: Medicaid funds--\$440,214, and non-Medicaid funds--\$51,443, for a total of \$491,657. Since its inception, the program has demonstrated that it can sustain operations with revenue generated as long as it is appropriately staffed.

STATE CRIMINAL ALIEN ASSISTANCE PROGRAM

An application has been prepared by the Lexington-Fayette Urban County Government requesting federal funding under the 2010 State Criminal Alien Assistance Program (SCAAP). The program is offered by the Bureau of Justice Assistance, a part of the Office of Justice Programs in the U.S. Department of Justice in conjunction with the U.S. Department of Homeland Security. This program is governed by the Immigration and Nationality Act, 8 U.S.C. §1231 (i) as amended, and Title II, Subtitle C. Section 20301, Violent Crime Control and Law Enforcement Act of 1994, Public Law 103-322.

SCAAP provides funds to States and localities as reimbursement for costs of incarcerated undocumented criminal aliens. Reimbursable costs are for inmates who are foreign born (with no legal right or documentation to be in the United States), incarcerated for at least four consecutive days during the reporting period (July 1, 2008 to June 30, 2009), and incarcerated on conviction of at least one felony or two (2) misdemeanors. Immigration and Customs Enforcement (ICE) will take responsibility for ensuring that aliens are properly identified and their status verified before reimbursements are made.

The FY 2010 SCAAP payment amounts are determined using a sampling of actual inmate, cost and facility data for a specified sampling or reporting period. SCAAP is not a traditional reimbursement program in which the actual cost, facility and data are collected. SCAAP uses prior year's data, from a specified sampling period, to determine applicants' annual relative percentages of available funding. For the 2009 SCAAP, the actual revenue to the LFUCG was \$181,107. The Bureau of Justice Assistance cautions applicants about using the prior year award as a basis for estimating this year's award. Immigration and Customs Enforcement (ICE) will review all information submitted on eligible inmates to make final determination of which inmates are qualified undocumented criminal aliens. Any funds received from the 2010 SCAAP must be used for a corrections purpose.

Basic center operations include advocacy, counseling, education, health promotion, access to legal assistance, outreach, recreation, and telephone reassurance. LFUCG staff includes a center director, an outreach worker, a staff assistant senior, a part-time receptionist, and two part-time van drivers. The center also houses several other agencies that serve older persons. These agencies, each having their own budgets, funding sources and staff, include the Hire Older Workers Program, the Senior Community Services Employment Program, the Nursing Home Ombudsman of the Bluegrass, Retired Senior Volunteer Program, the adult day care program and nutrition programs.

It is estimated that \$90,554 in federal funds will be available in FY 2011. The minimum local match required for the operation of the project is 15%; however, the amount that has been requested in the FY 2011 general fund budget for grant match is \$160,146. An additional \$13,000 in program income will be provided by agencies and individuals who utilize the Senior Citizens Center. The total cost of operations for this project is \$263,700. Grant funds are used for personnel costs, utilities, travel, and other operating costs of the center.

The Division of Waste Management's sole source purchase of waste collection bodies from Heil MultiPack is part of a plan to transition toward a uniform truck for the majority of residential collection services that will provide a number of operational efficiencies for the Waste Management Division.

We currently have five of these trucks in the Solid Waste fleet and 24 are on order with the first eight to arrive in May 2010. We have an opportunity to purchase a 25<sup>th</sup> truck and remain within the FY 2010 vehicle replacement budget. Therefore, we request approval to purchase a Heil Python MultiPack truck body not to exceed \$161,358 from Central Indiana Truck Equipment Corporation.

The truck body features <u>both an automated arm for collecting carts and a rear loader hopper for collecting larger items</u>. Heil is the only manufacturer that combines both these features in the same truck body. A recent review of the operational cost of these vehicles on a per mile basis shows that they are less expensive to operate than other automated units in the fleet.

The advantages of using this specific truck body include:

- 1. The MultiPack truck automated feature will replace our existing semi-automated collection vehicles which are more labor intensive. This will decrease our employee injury rates and increase the number of households serviced per route.
- 2. Replacing our existing automated collection trucks with the MultiPack trucks will enable DWM to eliminate our current bulky item trucks that retrace the automated collection routes (at a 3 to 1 ratio) to collect materials that the automated trucks cannot collect.

- 3. This MultiPack collection body can be assigned to any of the three collection streams: recycling, organics, or landfill bound waste as needed on any given day. This means that we will move from three different types of collection trucks that are currently being used to one type which will reduce the number of spare trucks needed and will streamline our maintenance needs and training requirements.
- Achieving route efficiency will be easier because the MultiPack truck will enable DWM to service streets that would have otherwise been inaccessible with our existing automated trucks.

The Division of Facilities Management & Fleet Services requests Resolution # 51-2010 to Tri-County Ford Mercury, Inc be rescinded for the purchase of two (2) Ford F550 trucks with snow removal equipment in the amount of \$97,014.00.

Based on snow removal operations from this past snow season, the Division of Streets & Roads has requested the F550 engine be diesel and not gasoline. Fleet Services recommends re-bidding for two (2) Ford F550 or equal with diesel engine and snow removal equipment. The advantages of a diesel engine:

- Power/Torque—The torque advantage of diesels is perfectly suited for pulling/pushing heavy loads such as a snow plow, a bed loaded with salt, or a trailer transporting "off road" equipment.
- 2. Fuel Economy--Diesel fuel has a higher energy density than gasoline, making diesel engines more efficient per gallon of fuel burned. In addition diesels use about one third as much fuel at idle as gasoline units.

Special Council Planning Committee March 23, 2010 Action Summary

Gorton chaired today's special meeting of the Planning Committee calling it to order at 9:00 am. Council members present: Gorton, Blues, Gray, Ellinger, James, Lawless, Beard, Feigel, Stinnett and McChord.

Motion by Gray, seconded by Lawless to move the text amendments below to the full council at work session March 23, 2010 to initiate a text amendment of the zoning ordinance, passed without dissent.

**Boarding/Lodging House**: Five or more unrelated individuals living together, but not as a family;

Congregate Living Facility: Eliminated as unnecessary

Family or Housekeeping Unit: A person living alone, or any of the following groups living together and sharing common living and kitchen facilities:

- a. Any number of persons related by blood, marriage, adoption, guardianship, or other duly authorized custodial relationship;
- b. Four or fewer unrelated persons;
- c. Two unrelated persons and any children related to either of them or under their care through a duly authorized custodial relationship;
- d. Not more than eight persons who are:
  - 1. Residents of a "home-like" residence as defined in KRS 216B.450
  - 2. "Handicapped" as defined in the Fair Housing Act, 42 U.S.C. Section 3602(h). This definition does not include those currently illegally using or addicted to a "controlled substance" as defined in the Controlled Substances Act, 21 U.S.C. Section 802(6).
- e. Not more than 6 unrelated individuals when in compliance with the provisions of the definitions of "dwelling, single family" or "dwelling, two-family" as contained in this Article.
- f. A functional family as defined and regulated herein.

Functional Family: No change recommended;

**Fraternity** or **Sorority House**: a building used as a living and/or gathering quarters for students of a college, university, or seminary (not living in a "dormitory" as defined herein) who are members of a fraternity or sorority that has been or is seeking to be officially recognized by the college, university or seminary; or their guests. In identifying such use, the following factors shall be among those considered regardless of number of occupants:

- a) signage or other indications that the building is used by a fraternity or sorority;
- b) fraternity or sorority sponsored social activities such as meetings, parties, dances, or other gatherings; and,
- c) events to which fraternity or sorority alumni or prospective members are invited.

## ADD A NEW SECTION PERTAINING TO THE BOARD OF ADJUSTMENT (ARTICLE 7-6(a)(8)):

- 8) The granting of a conditional use permit for a "functional family" shall be based upon application of the following considerations by the Board:
  - a. Members of the functional family will share a strong bond or commitment to a single purpose (e.g., religious orders):
  - b. Members of the functional family are not legally dependent on others not part of the functional family:
  - c. Members can establish a legal domicile as defined by Kentucky law;
  - d. Members share a single household budget:
  - e. Members prepare food and eat together regularly;
  - f. Members share in the work to maintain the premises:
  - g. Members legally share in the ownership or possession of the premises:
  - h. <u>Members demonstrate stability in the arrangement as opposed to transient living arrangements.</u>

<u>DWELLING</u>, <u>SINGLE FAMILY</u>- A building occupied exclusively for residential purposes by one family or one housekeeping unit. <u>This definition also includes a building occupied by 5 or more unrelated individuals at any time within five years prior to January 1, 2010 subject to the following:</u>

- a) the occupancy is restricted to 6 or less unrelated individuals:
- b) the use of the building as a rental dwelling has not been abandoned:
- c) the building shall not be enlarged or expanded beyond the existing square footage as of January 1, 2010
  - 1. by more than 25% unless the building has been expanded by 25% or more under a building permit issued on or after January 1, 2005, in which case, then by no more than 5%; or,
  - 2. unless approved by the BOA as a conditional use after January 1, 2010.

<u>DWELLING. TWO-FAMILY</u> - A building occupied exclusively for residential purposes by two families or two housekeeping units commonly known as a duplex. Townhouses are not included in this definition. This definition also includes a building occupied by 5 or more unrelated individuals in a unit at any time within five years prior to January 1, 2010 subject to the following:

- a) the occupancy of each unit is restricted to 6 or less unrelated individuals:
- b) the use of the building as rental dwellings has not been abandoned;

- c) the building shall not be enlarged or expanded:
  - 1. by more than 25% unless the building has been expanded by 25% or more under a building permit issued on or after January 1, 2005, in which case, then by no more than 5%; or,
  - 2. unless approved by the BOA as a conditional use after January 1, 2010.
- d) the limitation on enlargement of the building set forth in c) above shall not apply in the case of the addition of a second unit in a two-family (R-2) zone provided that both units thereafter conform to the limitation of four unrelated persons per dwelling unit.

# BUDGET & FINANCE COMMITTEE SUMMARY 3-23-2010

Stinnett called meeting to order at 1:02. All committee members present, Feigel attended as a non-voting member.

1. Review and Discussion of FY 2010 Financials for February, 2010 (monthly & YTD) - Rumpke \* Financial Reports for February, 2010) - Comm. Rumpke gave financial update and economic indicators - Presentation included unemployment rates permits issued new business licenses home sales and foreclosures. Bill O'Mara gave Feb. actual/approved budget & Feb. YTD actual/approved YTD budget OLT withholding net profit from Oct. to Feb. Revenue Review- Feb. FY 2010 Financial highlights Feb YTD for FY2010 - covered total revenue, personnel & operating expense, other categories and net change.

Stinnett asked about net change of 3.736 (referring to a number shown in financial highlights Feb. YTD for FY2010 slide) confirming we are not 3.7 ahead of budget. Gray also asked if 3.7 are annualized. There was discussion about this chart.

#### 2. Bond Underwriting Strategies - Rumpke

Hilliard Lyons was invited to speak on bond ratings and debt management. Steve Grossman, Chip Sutherland, Greg Phillips gave a presentation: LFUCG bond ratings: Moody's and Standard & Poor's LFUCG =AA (what do ratings mean and why they are important) - covered criteria such as economic, financial strength, management, and debt. Presentation shared Moody's rating comments on LFUCG and its debt profile. They Showed 2 future borrowing scenarios and talked about debt management, and about pension and full CIP bonding and pension and partial CIP bonding.

Gorton asked a question about dedicated revenues that can not be used for general fund, referring to pension and full or partial CIP bonding wanting to know which would be considered favorable. Answer: more about structural balance.

James question about taking advice from Moody's and it's rating system. Answer: it's not a perfect system, they are changing their rating system, but people who make bonds rely on them and an important part of the interest rate everyone pays Ellinger question about where we stand today compared to what we've agreed to do. They showed the slide "what debt profile looks like today" to answer his question and talked about issuing pension and full CIP on top of debt we already have today. Gray asked questions about slide titled debt profile if it issues pension and full CIP. He asked O'Mara to comment. Other option is to stretch them out. Myers also had questions about debt profile if it issues pension and full CIP slide and about revenue generation. Answer: this is to bring information to council as they are making decisions about overall debt. Myers: need to look at the dollars coming in and that we are making best use of them. Stinnett asked about projections

Ellinger asked about bond rating and implications of going to a lower rating and was told the amount of debt and structural balance is being looked at very hard right now. We

have control over how much debt we issue, Lane asked if it might be helpful to delay one of the pension bonds maybe a year or two. Hilliard Lyons said they are not here to give recommendations but if less debt is better. Beard asked what our aggregate is. Rumpke will email that info.

Stinnett asked Rumpke about pension bond and getting in on low rates could this be a legitimate strategy. She replied we also have to factor in debt.

**3. Discussion of the Lexington Public Library's FY 2010 Budget - Myers** \* Letter dated 1/15/2010 from Larry Smith Chairman, Lexington Public Library Board of Trustees and legal Documents From Law Department Re: Lexington Public Library Funding. - Myers wants to ask questions about library budget and how they are spending money and if it is heading in the right direction for the city. Larry Smith, Chairman mentioned misconceptions about the library budget and items they are cutting back on to reduce costs such as, delaying projects, cutting back on hours of operation, etc.

Lane asked how they are addressing technology and changes they plan to make. Smith said we are keeping up with technology as much as our budget will allow., adding we have seen increased use in computers and expecting the library to provide that service. They are currently looking at their policy on technology and estimate they are about 80% there. Stinnett asked about operating budget and sources of funding. Stinnett also asked about employee raises and budget surplus and was told the debit service ratio is 6%

Gray asked about donations and spending money on art and was told the library does not buy expensive items. Gray mentioned a piece of art at the airport that might be sold for funding. Lane asked for an update on repairing the pendulum clock and was told, it's under repair, however there was not a maintenance fund set aside for things like the clock. Myers asked about Carnegie Center funding. A representative from the library explained Carnegie Center funding and method of employee compensation and pay raises. Logan Askew commented about library tax. Myers talked about 5 cents from library funding and contributing to budget cuts. Feigel - (non- voting member) asked Mr. Askew about going to court to say the city is not funding library appropriately. Askew said an agreement for funding was reached between library and city. She asked how the state could mandate how a city spends resources and. would this apply to other entities such as parks, etc. Askew referred to a 1960 statue. Myers talked about the library parking garage.
