PURCHASE OF BULLETPROOF VESTS—FY 2011

On May 6, 2010 (Resolution No. 251-2010), Council approved the submission of an application to the U.S. Department of Justice requesting federal funds for the purchase of bulletproof vests for law enforcement officers in Fayette County.

The purpose of the Bulletproof Vest Partnership Grant Acts of 1998 (Public Law 105-181 and 2000 Public Law 106-517) is to save the lives of law enforcement officers by helping States and units of local governments equip their law enforcement officers with armor vests. The application can only be submitted by the local government. All law enforcement agencies in Fayette County that want to participate in the program must do so in a unified application with the lead entity being the LFUCG. A 50% local match is required.

The U.S. Department of Justice has offered the LFUCG an award of \$41,057.20. A 50% match is required. The Division of Police will be budgeted with \$37,387 in federal funds. Match funds in the amount of \$37,387 are budgeted in the Division of Police's 2011 general fund budget. Division of Police will be able to purchase approximately 100 vests. Federal funds in the amount of \$3,670 will be offered to the Fayette County Sheriff. The sheriff will provide match from her own budget. Sheriff's Office will be able to purchase 10 vests.

Council authorization to accept the award is hereby requested.

Purchase of Fire Simulation Software utilizing funds from the Assistance to Firefighters Grant.

This request seeks approval to purchase CommandSim Fire Department Simulation Software package and related onsite training services from Equipment Simulation, LLC. This software will allow the Training Bureau of the Division of Fire and Emergency Services to develop computer based simulations of emergency response scenarios. The software package will allow the scenario developers to add simulated smoke and fire to photographs and videos. The scenarios will be used to develop the decision making skills of Division of Fire personnel through training and evaluation in a controlled environment.

The software package allows multiple personnel to participate in a simulated emergency response scenario. It allows the scenario to change and evolve based on the decisions made by the participants.

The cost of this software package is \$28,950. The cost of the related on-site training is \$4,000.00. Pricing for this software package was obtained through RFP 39-2010. The attached action amends Section 21-5 abolishing two (2) positions of Telecommunicator Supervisor (Grade 116E) and creates two (2) positions of Telecommunicator Supervisor Sr. (Grade 117E) in the Division of Emergency Management/911, to become effective upon passage of Council.

The Division requests this action due to consolidation of 9-1-1 personnel from the Divisions of Police and Fire. New procedures and technology along with the influx of new personnel requires a dedicated position to provide a uniformed training program for both new and existing employees within the Division. Coordination of training of all Telecommunicator series employees will insure compliance with state training requirements and new technology and updated standards required to meet site certification standards.

Amending Code of Ordinances relating to ratification of probationary

appointment

Council authorization is requested to amend Sections 21-14, 22-13, 23-16 and 23-18 of the Code of Ordinances to bring these sections into compliance with the Americans with Disabilities Act.

Under the ADA, employers are prohibited from asking applicants questions relating to their medical history until after a conditional offer is made. Once a conditional offer is made, it can only be rescinded if the employee does not pass a medical examination. Pursuant to our hiring process, the Mayor and/or the Urban County Council have the ability to rescind an offer for other reasons after medical information is obtained. These amendments are designed to bring our Code of Ordinances in compliance with the current state of the law.

A copy of the proposed ordinance is attached. This proposed ordinance has been reviewed by the staff attorneys for the Kentucky Commission on Human Rights and meets their approval.

AN ORDINANCE AMENDING SECTION 21-14, SECTION 22-13, AND 23-18 OF THE CODE OF ORDINANCES PROVIDING THAT

BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT:

Section 1 – That Section 21-14 of the Code of Ordinances be and hereby is amended to read as follows:

- The appointing authority shall make all classified civil service appointments, probationary and permanent, subject to ratification by the urban county council. Prior to appointment, he shall receive recommendations from and delegate the responsibility for conducting pre-employment interviews to the supervisor in whose executive unit the vacancy exists. In all cases the appointing authority shall receive the recommendation of the chief administrative officer prior to submission of the appointment to the urban county council. Prior to making any classified civil service appointments, the urban county council shall ratify the appointments and authorize the appointing authority to make conditional offers.
- All classified civil service appointments shall be made only from the list of applicants certified by the commission after examination. Appointments shall be made only by the selection of one (1) of the five (5) holding the highest averages in the particular class and grade wherein the vacancy exists. All such appointments will be probationary pending completion of the probationary period. No employee appointed to pre-employment position requiring а physical physical examination or medical examination, as specified by the director, shall begin work until he has passed the required physical or medical examination. No employee shall be subject to a physical examination or medical examination until after a conditional offer has been made and accepted.

If an employee successfully passes his physical examination or medical examination, he may begin his probationary period.

- (c) Before permanent appointment, employees shall serve a six-month probationary period.
- (d) The probationary period shall be used for the effective adjustment of new employees through supervision, counseling and evaluation, as well as for the elimination of any probationary employees who do not meet the required standards of work. The appointing authority may terminate a probationary employee at any time during the probationary period without the right of a hearing before the commission.
- (e) No later than two (2) weeks prior to the conclusion of the probationary period, the employee's supervisor shall recommend in writing to the appointing authority the release or permanent appointment of the employee. The supervisor's recommendation shall not be binding on the appointing authority. A recommendation for permanent appointment shall be accompanied by a certification by the supervisor that the employee's probationary period has been successfully completed.
- (f) Prior to the conclusion of the probationary period, the appointing authority shall either terminate the employee under the same conditions as in subsection (d) or make a permanent appointment as provided in subsection (a). An employee who is not released prior to service of six (6) months in probationary status shall acquire permanent status automatically.

Section 2 – That Section 22-13 of the Code of Ordinances be and hereby is amended to read as follows:

The appointing authorities set forth in articles II and III shall make or recommend all appointments to positions covered by this chapter, subject to

ratification by the urban county council where provided. Prior to making an appointment, the urban county council shall ratify the appointment, where provided, and authorize the appointing authority to make conditional offers. No employee appointed to a position requiring a physical examination or medical examination, as specified by the director, shall begin work until he has passed the required physical examination or medical examination or medical examination until after a conditional offer has been made and accepted. If an employee successfully passes his physical examination or medical examination, he may begin his probationary period.

Section 3 – That Section 22-53.1 of the Code of Ordinances be and hereby is amended to read as follows:

- (a) The division of human resources shall create a register for appointment to positions in the police academy.
- (b) The examination for appointment to the police academy shall be comprised of a two (2) phase process. Phase I shall consist of a written examination, a physical fitness test, and an oral examination. Phase II shall consist of a psychological suitability screening test, polygraph examination, and background investigation.
- (c) Candidates shall be at least twenty-one (21) years of age and shall not have reached their thirty-seventh birthday by the application filing deadline date.
- (d) Prior to the academy class, the director shall close the date for applications for each class to be published as required by KRS Ch. 424.
- (e) The examination components shall be approved by the Kentucky Law Enforcement Council, and validated by the Division of Human Resources.

- (f) Phase I shall consist of the following:
- (1) A job-related written examination shall be prepared by the division of human resources. The test administrator shall provide each candidate with his score on the written examination and shall indicate to each candidate whether he is eligible to proceed.
- a. A different version of the written test shall be given for each hiring process.
- (2) Each candidate shall complete and pass the state required, certified physical fitness standard, Kentucky Peace Officer Professional Standards (POPS).
- (3) An oral examination shall be prepared and administered by the division of police.
- a. The oral examination board shall consist of the following five (5) members:
- 1. A police sergeant, or above, and the police chief or a designated representative;
- 2. Two (2) police officers appointed by the police chief;
- 3. A professional member of the community agreed upon by the director, the commissioner of public safety, and the chief of police; and
- 4. At least one (1) African-American and one (1) female. One (1) individual may not satisfy both requirements.
- 5. The director, or his designated representative, shall attend all sessions of the oral examination board as a neutral adviser and shall have no vote in any of the proceedings.
- 6. A member of the urban county council, to be appointed by the vice mayor, may attend all sessions as a neutral observer and shall have no vote in any of the proceedings.
- (4) After written and oral examination process, the representative and/or test administrator shall compute the scores of the candidates which will result in a preliminary ranking. Preference points equaling a two

- (2) percent upgrade to any candidate's score who has served in any branch of the United States military and has received an honorable discharge.
- (g) Phase II shall consist of the following:
- 1. The chief shall establish the maximum number of candidates who shall proceed to Phase II of the hiring process which shall consist of a polygraph examination, a psychological suitability screening test and background investigation.
- a. Upon completion of Phase II, all components from Phase I and II shall be reviewed and taken into consideration when recommending candidates for selection.
- b. The division of police shall supply the director with a list of those candidates whom the division recommends be eliminated from the current and future hiring processes The director shall accept the recommendation for elimination if the circumstances satisfy the requirements of KRS 95.430 and applicable sections of this Code. The aforementioned examination, test, and reports may also be used as a basis to remove a candidate at any other point in the process.
- (h) When vacancies arise in the division, the chief shall select names from the eligible list equal to the number of approved positions and a sufficient number of alternates.
- <u>(i)</u> Prior to submitting recommendations to the mayor, the director shall require that each recommended candidate undergo a medical examination and drug screen.
- (j) After all requirements have been met the chief shall forward his recommendation through the urban county government chain of command to the mayor with a recommendation for appointment. The mayor may accept or reject any recommendation made through the chain of command and shall have the sole prerogative to make the final appointments selections, subject to ratification by the urban county council. After the final selections are

made, the mayor shall submit the recommendations to the urban county council for approval to make conditional offers. After conditional offers are made and accepted, each selected candidate shall undergo a physical examination or medical examination and drug screening. All candidates who successfully complete the physical examination or medical examination and drug screening shall begin their probationary period.

- (k) If a candidate is selected for an academy and is unable to attend or complete the academy due to unforeseen circumstances, the director and chief of police will review the situation and decide if the candidate will be allowed deferral to the next academy. Any candidate who is allowed to defer to the next academy must pass a new physical fitness test, and Phase II requirements.
- (I) Upon the completion of the orientation section of the academy class, the list may be expired; however, the director and chief shall have the discretion to exhaust or maintain the register.
- Section 4 That Section 23-18 of the Code of Ordinances be and hereby is amended to read as follows:
 - (a) The division of human resources shall create a register for appointment to positions in the firefighter academy.
 - (b) The examination for appointment to the fire academy shall be comprised of a two (2) phase process. Phase I shall consist of a written examination, a physical fitness test, and an oral examination. Phase II shall consist of a polygraph examination, a psychological suitability screening test and a background investigation.
 - (c) Candidates shall be twenty-one (21) years of

age by the application filing deadline and shall not have reached their thirty-fourth birthday by the application filing deadline.

- (d) Prior to each academy class, the director of human resources shall close the date for applications for each class to be published as required by KRS Chapter 424.
- (e) The examination process shall be validated by the division of human resources.
- (f) Phase I shall consist of the following:
- (1) A job-related written examination shall be prepared and validated by the division of human resources. The test administrator shall provide each candidate with his score on the written examinations and shall indicate to each candidate whether he/she is eligible to proceed.
- a. A different version of the written test will be given for each recruitment cycles.
- (2) Each candidate shall complete and pass a job related physical fitness test which has been approved by the division of human resources.
- (3) An oral examination shall be prepared and administered by the division of fire and emergency services.
- a. The oral board shall consist of the following six(6) members:
- 1. One (1) fire lieutenant, a fire captain, and the fire chief or a designated representative not below the rank of major, appointed by the fire chief.
- 2. A paramedic, appointed by the fire chief.
- 3. A firefighter, appointed by the fire chief.
- 4. A professional member of the community appointed by the fire chief with approval from the director and commissioner of public safety.
- 5. At least one (1) African-American and one (1)

female. One (1) individual shall not satisfy both requirements.

- 6. The director, or his designated representative, shall attend all sessions of the oral examination boards as a neutral advisor. He or his designee shall have no vote in any of the proceedings.
- 7. A member of the urban county council, to be appointed by the vice-mayor, may attend all sessions as a neutral observer. He shall not have a vote in any of the proceedings.
- (4) After the written and oral examination process, the representative/test administrator shall compute the scores of the candidates' preference points equaling a two (2) percent upgrade will be applied to any candidate's score who has served in any branch of the United States military and who has received an honorable discharge. Any candidate with a current Kentucky or National Registry paramedic license shall receive a ten (10) percent upgrade to his or her final score. Any candidate with a current Kentucky or National Registry EMT certification shall receive a five (5) percent upgrade to his or her score. Only one (1) of the paramedic or EMT certifications will be applied to each applicable candidate's score.
- (g) Phase II shall consist of the following:
- (1) The fire chief shall establish the maximum number of candidates from the testing procedure who will proceed to Phase II of the hiring process. Phase II shall consist of a polygraph examination, a psychological suitability screening test and a background investigation.
- (2) Upon completion of Phase II, all components of Phase I and II will be reviewed and taken into consideration when recommending candidates for selection.
- a. The division of fire shall supply the director with a list of those applicants whom the division recommends be eliminated from current and future

hiring processes. The director shall accept the recommendation for elimination if the circumstances satisfy the requirements of KRS 95.440 and applicable sections of the Code of Ordinances. The aforementioned examination, test, and reports may also be used as a basis to remove a candidate at any other point in the process.

- (h) When vacancies arise in the division, the chief shall select names from the eligible list equal to the number of approved positions and a sufficient number of alternates.
- (i) Prior to submitting recommendations to the mayor, the director shall require that each recommended candidate undergo a medical examination and drug screening.
- After all requirements have been met, the chief (j) shall forward his recommendation through the urban county government chain of command to the mayor with a recommendation for appointment. The mayor may accept or reject any recommendation made through the chain of command and shall have the sole prerogative make the final appointments selections., subject to ratification by the urban county council. After the final selections are made, the mayor shall submit the recommendations to the urban county council for approval to make conditional offers. After conditional offers are made and accepted, each selected candidate shall undergo a physical examination or medical examination and drug screening. All candidates who successfully complete the physical examination or medical examination and drug screening shall begin their probationary period.
- (k) If a candidate is selected for an academy and is unable to attend or complete the academy due to unforeseen circumstances, the director and chief will review the situation and decide if the candidate will be allowed deferral to the next academy. Any candidate

who is allowed to defer to the next academy shall again pass applicable Phase I and Phase II requirements.

(I) Upon the completion of the orientation section of each academy class, the list shall be expired. However the director and fire chief shall have the discretion to exhaust or maintain the list.

For the First Item: The Division of Water Quality requests approval of Change Order #2 for TEAM Contracting for additional work to the Town Branch WWTP Primary Effluent Pump Station Pump Replacement project. Change Order #2 is for a total amount of \$16,674.85.

The amount of the change order includes funds for additional labor and equipment for removal and relocation of a 12" ductile iron drain line found during excavation in wet well #2. This pipe was not shown in this location on the as-builts from the construction to the plant in the late 80's, a deduct for a decrease in height for aluminum stairs, and additional wiring that was necessary due to the condition of the wire that wasn't exposed until demo began.

Budget & Finance Committee November 23, 2010 Summary

CM Stinnett chaired the meeting calling it to order at 1:00 pm. All committee members present, except CM James and Henson. CM Martin attended as a non-voting member.

Review and Discussion of FY 2010 Revenue for October

Linda Rumpke started today's update telling the committee the report was slightly changed by adding performance information on all funds. She mentioned the Federal Reserve's recent announcement to inject money into the economy, saying it is having an effect on the bond market.

She covered comparative unemployment rates saying the national rate has remained flat, and the state is pretty much following suite with this trend. We are seeing a bit of decline in the state level of unemployment. Fayette Co. was down in Sept. and October numbers are not available yet. She also showed comparative unemployment rates three month average. Economic indicators, state was up 7300 jobs however construction permits and home sales still down. Stinnett commented about new home starts.

Bill O'Mara gave Oct. actual/adopted budget revenue numbers saying net profit is still below budget.

Lane asked about employee withholdings Oct YTD actual/adopted YTD budget numbers shown - O'Mara said the numbers are disappointing.

Lane commented about employment and there was a question from Beard about types of jobs lost.

Oct YTD actual less amnesty/adopted YTD budget this shows us our revenues are flat. Stinnett pointed out reason for showing this slide for the benefit of viewers at home. OLT withholding Jan.-Oct OLT net profit percent of change Jan-Oct is -9.9%.

Martin asked how many years of declining profits have we had in the last three recessions. O'Mara said we had 2 years in net profits, if the past is a predictor we should pull out by end of this fiscal year. Gray also asked about history of net profit numbers in past recession years.

Ryan Barrow showed financial highlights Oct YTD 2010. He pointed out attention to personnel expense which includes actual health insurance cost. He wanted to focus on budget numbers, saying that will change, He also talked about (6.811) net income explaining what is driving that number.

He showed financial analysis assuming sale of real estate and how much of the economic contingency draw would be required, sharing two scenarios, with and without sale of real estate.

Stinnett asked Rumpke and Barrow to explain Medicad re-imbursement (4.7 million dollars) Rumpke said this wasn't collected and was not a guaranteed receivable, physical accounting treatment did not allow since the state couldn't give a date certain.

Beard asked status of selling LFUCG real estate and was told Commissioner Cole, General Services is currently working on that. However specifics can not be discussed during this meeting without going into closed session.

Martin said we can not count on selling the real estate and wanted to know if there is a contingency plan in that event. Rumpke said we are trying to give council the best numbers available as they attempt to balance this budget.

Gorton asked if there's been an aggressive attempt to sell the real estate and expressed interest in having a conversation with Commissioner Cole about progress. She's said we are almost one half of the way through this fiscal year and I am extremely concerned about the financial analysis without selling this property. It's taken many years to build up the economic contingency fund and this scenario would require almost half be drawn from it in order to balance the budget. Rumpke said we have to focus on net income and expense items and its impact.

Gorton asked for a report from Commissioner Cole regarding sale of the real estate at the next work session. Stinnett asked Rumpke to coordinate that with Commissioner Cole in order to go into closed session to discuss at the next council meeting.

Martin called for need of a game plan. Rumpke said our discipline has not changed regarding cash flow management. Martin shares Gorton's concern about spending economic contingency. He said we may need \$15 million for a catastrophic event and urged managing this revenue crisis without that option.

Rumpke mentioned the challenge with personnel expenses. Stinnett commented we are not in this boat alone sharing info about federal government budget. He asked that Cole be ready with real estate property sale info on Dec. 7, 2010. He asked about the actuarial study. Rumpke said we can't close books without it and our goal is to get the study issued, she estimated the January, 2011 meeting would include that presentation.

No motions came forward from today's proceedings.
