Funding for Mast Arm poles at intersections

Resolution 370-2010 (passed Urban County Council July 1, 2010) established a reimbursement to the Kentucky Transportation Cabinet (KYTC) upgrading the Mast Arm poles at the intersection of Newtown Pike Extended (Oliver Lewis Way) and US 25, Newtown Pike Extended (Oliver Lewis Way) and KY 1681 and Newtown Pike Extended (Oliver Lewis Way) and US 60. At that time the estimated cost of this reimbursement was \$216,098.97. While completing the work at these intersections the KYTC experienced additional cost and have requested that the Lexington Fayette Urban County Government (LFUCG) increase the reimbursement amount to \$273,056.73 (an increase of \$56,957.76).

We are requesting that the Lexington-Fayette Urban County Council rescind Resolution 370-2010 and authorize the Mayor to sign the revised "Agreement for Services to be Performed for Governmental Agencies" for the subject project.

On June 26, 2008 (Ordinance No. 149-2008), Council authorized acceptance of federal funds from the Kentucky Transportation Cabinet for the conversion of communication and data lines in the Lexington traffic signal system. The source of federal funds is the Congestion Management/Air Quality Program. The project has two goals: (1) to provide a more reliable communication medium for the traffic signal system, with the objective of reducing harmful emissions, and (2) to lessen the impact of severe electrical storms and other inclement weather conditions, in addition to aberrant telephone line communications on traffic signal communications. Funds are used to support the costs of fiber optic cable installation and to support the costs of video equipment/data communications integration.

On October 14, 2010 (Ordinance No. 168-2010), Council approved Amendment to the Agreement, providing for modifications to the grant budget. This project expires on July 10, 2011.

The Kentucky Transportation Cabinet has offered the LFUCG an Amendment to the Agreement providing for an extension through July 9, 2012.

No other changes are proposed.
