On July 5, 2012 (Resolution No. 365-2012), Council authorized submission of an application requesting federal funding under the 2012 State Criminal Alien Assistance Program (SCAAP). This federal program is offered by the Bureau of Justice Assistance, a part of the Office of Justice Programs in the U.S. Department of Justice in conjunction with Immigration and Customs Enforcement (ICE). This program is governed by the Immigration and Nationality Act, 8 U.S.C. \$1231 (i) as amended, and Title II, Subtitle C. Section 20301, Violent Crime Control and Law Enforcement Act of 1994, Public Law 103-322.

SCAAP provides funds to States and localities as reimbursement for costs of incarcerated undocumented criminal aliens who have been in custody for at least four consecutive days, and have been convicted of a felony or two misdemeanor offenses. Reimbursable costs are for foreign-born inmates who have 1) entered the U.S. without inspection, 2) was subject of exclusion or deportation proceedings at the time of being taken into custody, and/or 3) admitted as a nonimmigrant at the time of being taken into custody who has failed to maintain the nonimmigrant status. ICE takes responsibility for ensuring that aliens are properly identified and their status verified before awards to state and local governments are made.

The FY 2012 SCAAP payment amounts were determined using a sampling of actual inmate, cost and facility data for a specified reporting period. SCAAP is not a traditional reimbursement program in which the actual cost, facility and data are collected. SCAAP used prior year's data, from the period of July 1, 2010 through June 30, 2011, to determine applicants' annual relative percentages of available funding. The award for 2012 has been announced as \$65,503. The Department of Justice Reauthorization Act of 2005 (Pub. L. 109-162, Title XI) requires that all SCAAP funds be used for correctional purposes only. The Division of Community Corrections is requesting that funds be used for training/education for offenders, re-entry programming, technology to improve offender management, and training for correctional officers related to offender population management. No matching funds are required.

The Division of Police has prepared an application for submission to the Kentucky Justice Cabinet requesting federal funds in the amount of \$45,123 from the Violence Against Women Act (VAWA) Program for the continuation of a Sexual Assault Nurse Examiner (S.A.N.E.) program in the Division of Police as a response to sexual assault for females fourteen and above. The Division of Police, the Commonwealth Attorney's Office, the Fayette County Attorney's Office, and the Bluegrass Rape Crisis Center have collaborated on the planning and implementation of this project and have agreed to provide a coordinative response to the victims of sexual assault.

This project was begun in 2000 with the creation and filling of a full-time position of S.A.N.E. Project Director as a civilian employee in the Division of Police. Other S.A.N.E.s have been recruited to serve on-call on a contractual basis. S.A.N.E.s are registered nurses with specific credentials for the examination of rape and other sexual assault victims. The University of Kentucky Medical Center provides private examination and waiting space in its Emergency Room for this program. Dr. Brian Adkins, an attending ER physician, serves as medical director for the project. The purpose of this project is to provide the victims of sexual assault with better examinations for evidence and to give greater care to the chain of evidence with the objective of more successful prosecutions for sexual assault. It is anticipated that more humane treatment of the victim at the time of the examination will increase reporting and increase willingness to testify in prosecutions.

Total project costs for a 12-month period will be \$94,273. Of this total, the request for federal funding is \$45,123. Local match in the amount of \$28,150 is budgeted in the Division of Police's FY 2013 general fund budget. Funds will be used for contractual services, emergency room space, medication costs, cell phones, training and supply and equipment costs. It is projected that during a full project year, as many as 130 sexual assault examinations will be conducted. It is estimated that the S.A.N.E. Coordinator will perform approximately 25 of these exams in the course of her work.

The remaining 105 exams will be performed by S.A.N.E.s working under contract. It is anticipated that the state's Crime Victims Compensation Fund will pay \$200 for each of these exams, for a total estimated state revenue of \$21,000. The LFUCG pays the nurses at a rate of \$230. The remaining \$30 per exam (\$3,150 total) is included in grant match.

The Lexington-Fayette Urban County Government received federal funds from the U.S. Department of Housing and Urban Development in 1994 for the development of housing facilities for persons with AIDS. The two properties developed with these funds were:

- (1) a community residence, Solomon House, located at 851 Todds Road,, with the purpose of providing housing and support services to low-income persons with severe cases of AIDS.
- (2) an apartment building, located at 1807 Dalton Court, with the purpose of providing housing and support services to homeless and near homeless low-income persons who are HIV positive.

AIDS Volunteers, Inc. (AVOL), a private, nonprofit organization, is the sponsor for this project. The properties were originally leased to AVOL for operation and management in 1996. Since that time, AVOL has complied with all lease requirements and with all federal regulations.

The leases for these facilities are expiring and new leases with AVOL are proposed. The proposed leases make AVOL fully responsible for costs of maintenance and operation of both properties. Federal funds from the U.S. Department of Housing and Urban Development have been awarded for this purpose. The lease is for a period of one year, renewable for three additional 12-month periods, at a cost to AVOL of \$10.00 per year.

This memo seeks the approval of a contract between LFUCG and Public Financial Management, Inc. (PFM), a publicfinance consultancy based in Philadelphia, to provide consulting services to the Police and Fire Pension Task Force. The Task Force was formed to find consensus between LFUCG and the beneficiaries of the pension with respect to pension reforms.

PFM was selected through LFUCG's RFP process (#25-2012). The proposal selection team was comprised of the benefits subcommittee of the Police and Fire Pension Task Force, which includes police and fire representation, with two additional council members and a member of the Mayor's office.

A separate budget amendment has been submitted for \$210,000. That amendment would cover the cost of PFM - at a not-to-exceed price of \$149,089 -- with the balance covering the costs of Cavanaugh & MacDonald, Lexington's actuaries, for their work in generating impact analyses of suggested pension reforms. LFUCG is recovering half of the cost of consultants – up to \$80,000 – from donors outside of LFUCG.

OCTOBER 2ND, 2012

1. Kentucky Horse Park

John Nicholson came to the podium to present the Council Members an update on the Kentucky Horse Park. He said that the economic impact of the Kentucky Horse Park for FY10 was calculated to be \$180MM, including \$17.1MM in generated state tax revenue.

The Alltech FEI World Equestrian Games had a total economic impact of \$201.5MM. Revenues continue to increase. In 2011, state, regional, and national associations headquartered at the National Horse Center sponsored 63 events with 236 event days at the Horse Park. They hope to increase event competition days in the future.

Nicholson said that although they have been steadily increasing their revenues each year, the management team is evaluating the following areas to increase cash flow:

- Reduce expenses
- Seek local financial support
- Develop a site for private-sector hotel operator
- Expand the campground
- Create an annual festival

To protect the park's national and international reputation and enhance its future financial benefits to Kentucky's taxpayers, five key business strategies are essential:

- Make sure a reliable, long term source of revenue is available
- Invest in marketing and public relations to attract more events, competitions, and visitors

- ➤ Develop a private-sector hotel in partnership with the park to accommodate tourists, association meetings, and attendees at events and competitions
- Recruit more equine related associations to the National Horse Center and add more competitions to the park's event calendar
- Create an annual arts, cultural and culinary festival to celebrate and promote Kentucky's heritage

Nicholson said that FY07 was a difficult year and then the recession hit in FY08. They then had to build the infrastructure for the Equestrian Games. Last year, the Horse Park requested \$3.5MM. At the very end of the legislative session, they did get the requested funding. The General Assembly then requested a business plan from the Horse Park. They wanted to know how the Kentucky Horse Park would function without any state support.

Ellinger asked Nicholson about the timeline for the hotel. Nicholson said that they are waiting for litigation in the Court of Appeals from the 2008 hotel issue. He said that the concept will be a private sector hotel on a land lease agreement.

2. Commerce Lexington Quarterly Report

Bob Quick presented the Quarterly Commerce Lexington report. He reported that there are 66 new businesses, 18 existing and local entrepreneurial clients, 75 existing business visits and 28 site visits.

Kay requested that reports on employment for businesses receiving incentives include median salary as well as average salary.

Quick spoke about the Q4 FY12 new and expanding business list included in the packet. Amazon.com is planning 550 new jobs, Big Ass Fans is planning 150 new jobs, Toyota Motor Manufacturing Kentucky is planning 86 new jobs and finally, Xact Communications is planning 20 new jobs.

Quick mentioned the A & W Restaurants grand opening as well as the grand opening of Frog Dice. Quick also mentioned the expansions of Bingham McCutchen LLP, Birtley, PremierTox, and Nitto Denko into Fayette County.

Quick spoke briefly about minority business development and said that the Access Loan Program exceeded the \$10MM mark. He also told Council Members about their Entrepreneur Leadership Institute and the Best in the Bluegrass program that placed ten students in internships with the Mayor's Office, UK, Central Baptist Hospital and CustomKYnetics.

Gorton asked Quick about the Bluegrass Station and any efforts that Commerce Lexington makes to recruit Department of Defense industries. Quick said that they work with the Commanders and General to recruit, attract and expand these industries.

Gorton went on to ask Quick about any efforts with Agriculture. Gorton mentioned the UK College of Agriculture. Quick said that we have one of the best research facilities in the world for equine and plant science. He said that Commerce Lexington is always trying to grow that industry.

Martin asked Quick how many acres are available in Fayette County to build a manufacturing facility. Quick said that there are 80 acres. Martin expressed concern that we are not ready to bring in a defense sector jobs or a car manufacturer. Martin said that he does strongly support keeping Lexington is Horse Capital of the World, but encouraged the Council to think about where this type of industry or business would go if there was an opportunity to recruit a new industry or business.

Various Council Members spoke briefly about manufacturing and Quick mentioned the Bluegrass Alliance in response to a question from Lane regarding partnerships with other Kentucky counties.

3. Itinerant Merchant Task Force

Henson began her presentation on the Itinerant Merchant Task Force. She said that there are no regulations for itinerant merchants under the current ordinance. Henson said that early on, neighborhoods had voiced concerns about their entrances. In the draft, an itinerant merchant cannot operate within 100 feet of a residential dwelling. Their hours of operation would be limited to the hours of 7:00am to 11:00pm. If the itinerant merchant is on the property of a business that operates 24 hour a day, they must still close at 4:00am.

Sean Tibbits, the Director of the Food Truck Organization spoke. He placed a flowchart on the overhead illustrating the process to obtain permits for operation. Lane expressed concern about the complexities of the process.

Henson clarified to Council Members that the ordinance does not apply to the LFUCG public parks. She said that they have their own vendors and Barberie added that the vending decisions for the parks are made by the Division of Parks and Recreation.

Chris King said that the average zoning compliance permit takes 15 minutes to obtain. There are no fees associated with that permit. King said that the information on the flowchart is not all accurate. King said that he is committed to make the process simple and also wants to protect neighborhoods. King said that the ordinance may not need to be changed. He could simply make administrative changes within his department.

Farmer said that he was uncomfortable with the restrictive nature of the ordinance as well as the fees that are complicating the issue for the vendors.

Kay said that he would like to keep the issue in committee.

Barberie said that he would like to bring a flowchart to the next meeting illustrating the process. He also told Council Members that the more controversial issue is the pilot food truck program. Barberie said that other cities allow designated public areas for food trucks to operate.

Gorton asked about public parking spaces. Barberie said that the draft does not open up any public land any differently than how the ordinance is written now.

Motion by Gorton to adjourn. Seconded by Crosbie. Motion passed without dissent.

Social Services & Community Development Committee October 16, 2012 Summary & Motions

Chair Myers called the meeting to order at 1:02 PM. All members were present except CM McChord.

9.18.12 Committee Summary

On a motion by CM Kay, second CM Stinnett the 9.18.12 Social Services & Community Development Committee was approved.

Summer Youth Employment Follow Up

Commissioner Mills introduced the summer youth employment presentation. She introduced Mattie Morton the program coordinator of the summer youth employment program.

Ms. Morton discussed the parameters of the program. She stated that 150 youth were placed and employed by the program this past summer. She stated that the participants come from every Council District in the County but over half (53%) reside in 3 districts; the 1st, 2nd and 8th districts.

Ms. Morton stated that the participants were between 15-18 years old and the majority were 14-15 years old. She stated that the participants come from 18 of the 20 public middle and high schools in the County. Ms. Morton stated that most come from Bryan Station, Lafayette and Henry Clay. She stated that the youth are paid \$ 7.25 per hour.

She stated that 30% of the participants previously participated in the summer youth employment program. The participants were assigned to over 65 work sites. Most of the work sites have been involved in the program for multiple years.

Ms. Morton stated that there were ten (10) types of jobs available including landscaping, animal care, retail sales, warehousing, child care, reception/office, computer technology, maintenance, auto tech and food service. She stated that 76% of the participants were assigned to the office/receptionist and child care categories.

Ms. Morton reviewed the skills that the youth were exposed to and learned at their worksites. She also reviewed program performance measures used to evaluate the participants and the worksites.

Lane discussed income eligibility for the program.

Lawless stated that the program was very well run and it was a good investment for Lexington. She also discussed trans-generational poverty in Lexington.

Ford stated that the community had an opportunity to invest more resources in the program. He stated that the FY 13 budget increased funding to have an additional 75 youth participant in the program this coming summer. He stated that he would like the program to grow to at least 300 youth each summer.

Myers asked about the job types. He asked if school counselors were involved in the program to match the youth with career paths. In response Ms. Morton stated that they were not.

Myers asked whether the sites were ever required or encouraged to pay part of the participants' wages. He discussed varying the job types to make them more appropriate career paths. He also asked about financial literacy workshops.

Kay asked about the recruitment process. He stated that the worksites spend a great deal of time with the youth and acclimate the participants into a work environment. He stated that the summer employment program instills job skills in the participants.

Ford made a motion to increase participation to 300 youth in FY 14. The motion was seconded by Kay.

Crosbie asked about the intent of the motion. In response Mills stated that an increase from 150 to 225 in FY 13 and to 300 participants in FY 14 would mean increased administrative resources would need to be allocated to adequately support the program.

Myers stated that he supported the program but would like to see more employment opportunities for the participants rather than receptionist and child care positions. He stated that employers need a well trained work force to compete in the global economy.

Kay stated that a positive vote would send a message to the Administration to develop methods to increase participation. He stated that the program benefits young people and our community as a whole.

Lane discussed the Junior Achievement program and youth training. Myers followed by comments from Lane and stated that the program should expand opportunities for our youth and include jobs in emerging industries and fields.

Debbie Sharon and Jane Peck spoke on half of work sites in favor of the program. They stated that the youth were motivated to work and had improved job skills during the duration of the program. They both stated that the participants contributed to the work sites.

Ford clarified the motion regarding establishing a baseline of 300 participants for FY 14.

Myers asked if the motion could include a statement that the employers should pay a portion of the youth salaries. In response Ford stated that he wanted the administration to have flexibility in managing the program. He stated that the worksites invest their time

and training in the participants. He stated that it can be challenging to bring teenagers into their work environment.

On a motion by Ford, second Kay the committee approved establishing a baseline of 300 summer youth employment slots by FY 14.

Committee Referrals

On a motion by Lawless second Lane the Senior Citizen Center issue was moved to Work Session. Motion was approved unanimously.

The meeting was adjourned at 12:25PM

BUDGET & FINANCE COMMITTEE October 23, 2012 Summary

Ellinger called the meeting to order at 1:00 PM. All committee members present except Lawless.

1. 9.25.12 Committee Meeting Summary

A motion by Beard, seconded by Blues to approve the 8.28.12 Committee summary passed unanimously.

II. Monthly Financial Report

Jane Driskell introduced the monthly financial report. She stated that the audit was on schedule and a detailed report will be provided at the November Budget & Finance Committee.

Bill O'Mara provided the revenue portion of the monthly financial report. He stated that the 3-month trend economic indicators were moving in a positive direction. He stated some of the September monthly indicators, including building permits, business licenses, home sales and foreclosures, were on a negative slope but cautioned against examining the monthly indicators too closely because seasonal changes and timing issues can impact those monthly numbers.

O'Mara discussed the year to date General Fund revenue statement. He stated that while some of the actual revenue categories were flat or in a negative position compared to budgeted revenue, actual revenue was slightly above budgeted revenue by approximately \$ 1.2 million.

In response to a question from Councilmember Lane, O'Mara stated that Franchise Fee revenue was down primarily berceuse of weather conditions.

Lane asked a question about the Services revenue category being higher by over \$1 million. In response Ryan Barrow stated that the increase is a timing issue related to medical reimbursement at the Detention Center as well as being a function of higher rents/leases being charged by the Urban County for some building space.

Barrow stated that the increase in the Intergovernmental category was also a timing issue.

Barrow discussed the fiscal year expenditure report. He stated that personnel costs were below projected budget by over \$ 2.5 million. He also stated that operating costs were slightly above the projected budget by approximately \$ 300,000.

Barrow stated that General Fund actual expenditures are below budgeted expenditures by approximately \$ 2.8 million year to date.

No motions came from this item

III. Urban Development Action Grant (UDAG) Balance

Ellinger stated that the current balance in the UDAG Fund was \$ 133,397 after Council approved of the \$ 1,000,000 loan to the 21C Hotel project and the \$ 20,000 allocation for a multi-use field at Shillito Park.

Gorton asked Jane Driskell if the Administration was requesting any of these funds for HOME match. In response Driskell stated no.

Myers spoke about the \$80,000 request for the Berry Hill skate park project.

Myers spoke about the \$ 100,000 request for the Gainesway Small Area Plan. He stated that this was the District's highest priority.

A motion by Myers, seconded by Farmer to remove the Gainesway capital project from the UDAG list passed unanimously.

Lane spoke about the roof of the Old Courthouse project.

Gorton stated that the original request was for mold & lead abatement.

Beard stated that the original estimate to rehabilitate the Old Courthouse was \$ 12 million which has now escalated to \$ 18 million.

Jamshid Baradaran discussed plans to address the roof, mold & lead abatement and building structure. He stated that it would take more than \$20,000 to address the roofs at the Courthouse.

A motion by Lane, seconded Blues to amend the Old Courthouse request to \$ 20,000 passed on a 7-2 vote (Ellinger, Kay, Farmer, Myers, Beard & Blues-Yes; Gorton & Stinnett-No).

Farmer spoke about the Chevy Chase intersection redesign project. He stated that the Corridors Commission allocated \$ 3,500 to the project.

A motion by Farmer, seconded by Myers to amend the Chevy Chase project request to \$31,500 passed unanimously.

Heather Lyons spoke about the Living Arts & Science Center (LASC) request. He stated that their request was reduced to \$80,000. She stated that \$1.9 million had been raised already for their capital campaign. She stated that \$80,000 from the UDAG Fund would be used to match the Lucille Little Fund grant.

Gorton asked a question about the trail match request. In response CAO Moloney stated that the bridge over New Circle would cost \$ 350,000 and an additional \$ 150,000 for the trail.

Ellinger asked if anyone objected to the late item from Blues.

Blues spoke about the \$2,122 requested for the engine brake signs.

Myers asked about adding a location for the signs. In response Blues stated that the locations came from Traffic Engineering.

Stinnett asked if the appropriation could come from the Corridors Commission

Kay requested that Scott Shapiro address another late item.

Shapiro requested that \$80,000 be added to the request list to retain a consultant to examine the Police & Fire Pension system. He stated that this item was an economic development issue.

On a motion by Kay, second Lane a motion to add \$ 80,000 to the request list to retain a Police & Fire Pension Plan consultant passed 8-1 (Ellinger, Lane, Gorton, Kay, Farmer, Stinnett, Beard & Blues-Yes; Myers-No).

Ellinger stated that that was the end of presentations on the various projects. He stated that it would now be appropriate for motions to allocate up to the balance of the UDAG Fund.

Kay stated that the Living Arts and Science proposal best fits the purpose of UDAG funds.

Ford stated this was a shovel ready project and would be a tremendous opportunity for the entire community.

A motion by Lane, seconded Gorton to allocate \$ 60,000 for the Living Arts & Science Center passed unanimously.

A motion by Farmer, seconded by Lane to approve \$ 31,500 for the Chevy Chase intersection redesign was approved unanimously.

Beard asked Shapiro why the Administration started the consultant procurement process without the funds in place to fund such a study. In response Shapiro stated that the Administration is seeking funds. He also stated the some private funds had been secured for the work.

Driskell stated that they will identify funds before engaging in a contract for the consultant work.

Lane stated that while the pension was a critical issue, it was not appropriate to fund the consultant work with UDAG funds.

Stinnett stated that the Administration should recommend that the fund balance be used to pay for the consultant work. Stinnett also asked about the private donors agreeing to fund the study. In response Shapiro stated that private sources had agreed to partially fund the study but LFUCG had not yet received such funds.

A motion by Gorton, seconded by Beard to approve \$ 2,122 to the brake signage project passed with an 8-1 vote. (Ellinger, Lane, Gorton, Kay, Farmer, Myers, Beard & Blues-Yes; Stinnett-No.)

Gorton discussed the Gainesway Small Area Plan. She stated that the Comprehensive Plan had identified the need for a plan for the area for some time. She stated that these plans were very effective in engaging the community and developing an action strategy to revitalize neighborhoods. She stated that funds had not been allocated in the General Fund for small area plans for several years.

Stinnett stated that if the plans are a priority they should be requested and considered for funding during the normal budget process.

Myers spoke in favor of the small area plan.

Ford suggested that the small area plan and the Living Arts & Science Center split the remaining funds.

A motion by Gorton, seconded by Myers to allocate \$ 39,775 to the Gainesway Small Area Plan passed by a 7-2 vote (Ellinger, Gorton, Kay, Farmer, Myers, Beard & Blues-Yes; Lane & Stinnett- No).

IV. Referred Items

Ellinger stated that the Procurement Task Force would re-convene to consider the outstanding purchasing items.

It was announced that the Waste Management Task Force would meet Thursday Oct 25.


Kay updated the committee on the affordable housing item.





For developments <u>not</u> requiring construction of public infrastructure, Permanent Allocation of capacity/credits is required prior to issuance of building permit. In either case, a tap permit shall not be issued without certification of adequate capacity or proof of credit allocation.

A capacity/credit **Reservation** may be made anytime after <u>submission</u> of a Preliminary Development Plan. Reservations shall expire after 1-year. A 1-year extension may be requested. After 2 years, re-application will be necessary.

Infill and Redevelopment Steering Committee 2012 Annual Report

History

After the 2000 Residential Infill Study, a small group of elected and appointed officials, development and neighborhood interests, and staff starting meeting as an ad hoc Infill and Redevelopment Steering Committee. The Committee was reorganized and expanded in 2007 as part of the decision not to enlarge the Urban Service Boundary. Three (3) task forces were created to study and review infill and redevelopment efforts and prepare a comprehensive report. The entire process, which lasted approximately two years, identified, evaluated, and drew consensus on the major issues and opportunities related to infill and redevelopment. The report was issued in 2008 and detailed 104 recommendations to improve the quality of life, quality of place, and quality of process of the Infill & Redevelopment Area.

The report was updated in 2010 to highlight the objectives accomplished regarding zoning ordinance text amendments, the development of small area plans, the development of the Complete Streets recommendations, legislation for the Land Bank and Abandoned Urban Property Tax, operation of the Community Land Trust, review and streamlining of the development review process, and the completion of the Housing Market Study and Non-Residential infill and Redevelopment Study. The report also recommended returning to a large focus group instead of 3 work groups.

Current Status and Focus

Its initial task was to review the recommendations to determine what had been completed, what was in progress, what the priorities were, what the barriers were, and what the next steps were. It officially added thirteen (13) recommendations and removed items that had been completed. A copy of the Master List is attached as Appendix A. This process left 42 recommendations that needed attention or were in progress. A copy of the Current Focus list is attached as Appendix B.

The Committee recognized that the "low hanging fruit" of the recommendations had been picked leaving the more difficult recommendations remaining. Barriers to implementation include funding, ownership, or staffing capacity. The Committee separated the remaining issues into categories of housing, development process, environment, public space/art, or design with most of the recommendations falling into housing, design, or development process.

Since the last report, the Design Excellence Committee is working to implement design standards; and Planning is working on "Complete Street" standards, Corridor studies, and updating the Comprehensive Plan including small area plans. The Downtown Streetscape Master Plan has been completed.

The Committee is working to invigorate the Land Bank and the Vacant Property Review Commission, and combine the Public Art and Culture Master Plan Committee, and the Urban County Arts Review Board. One of the biggest achievements is the cooperation between Planning and the Property Valuation Administrator regarding vacant and underutilized property.

GIS Development Tracking

A primary focus of the Steering Committee has been to make data available to the public on-line and in real-time, if possible. Most of the discussion has centered on a GIS Development Tracking system for real time development tracking which would allow property to be followed from start to finish. It would integrate the permitting function into the GIS system and include Planning, Engineering, Building Inspections, Code Enforcement and Geo reference. It is an important economic development tool allowing us to find available land for development, pre-certify that land in some capacity, and then solicit investors. It will, however, need technical and integrated software that functions across the government. At the request of the Committee, money was placed in the 2013 budget for a pilot program which is currently being evaluated by Planning.

Code Enforcement

Believing that effective and efficient Code Enforcement plays a pivotal role in the appearance, safety, economic development, and redevelopment of property in the infill area, the Steering Committee initially focused on recommendation #96, "[p]rovide coordinated assistance to property owners with Code Enforcement violations." It prepared and reviewed a white paper regarding Code Enforcement and made the following recommendations. These recommendations have been referred to the Administration and Council.

I. Code Enforcement

- 1. Analyze current fine structure to determine if changes should be made regarding increased fines for subsequent offenses on the same property.
- 2. Review Code to determine if certain provisions are too restrictive.
- 3. Update the standard operating procedures and have them approved by Council.
- 4. Post a link to the International Property Maintenance Code on the website.
- 5. Post a copy of the Standard Operating Procedures on the website.
- 6. Post a copy of the field inspection form on the website.
- 7. Make the appropriate portions of the Code Enforcement database available to the public.
- 8. Redraft the notice and letters sent to violators to make them more informative and user friendly while including all legal requirements.

- 9. Request funds in the next budget cycle to hire an administrative position to file the Code Enforcement liens, draft and monitor abatement plans, and staff the Vacant Property Review Board.
- 10.Monitor the officers' files to determine if time frame and paperwork standards are being met and are consistent.
- 11. Follow the procedure outlined in the standard operating procedures for Comprehensive Inspections.

Legal Department

- 1. Rewrite Sec. 12-1(b) to make it easier to read.
- 2. Change "reasonable time" to "30 days or in compliance with approved plan," require that reasons be listed for any plan that is extended past 90 days, require officers to list reasons for deviation from plan and reasons for extensions in report, require civil penalties to be imposed after 6 months, and provide that transfer of property does not automatically restart time frame.
- 3. Request funds in the next budget cycle to hire a paralegal devoted solely to filing and managing foreclosure actions.
- 4. Request funds in the next budget cycle to contract with a hearing officer to handle Code Enforcement cases.

Council

- 1. Request a report to the Public Safety Committee in six (6) months from Code Enforcement and the Legal Department regarding the implementation of these recommendations.
- 2. Adopt recommended changes to the ordinance when they are developed by the Law Department.
- 3. Adopt recommended changes to the Standard Operating Procedures when they are developed by Code Enforcement.
- 4. Recommend to the Administration to increase the budget for the Legal Department during the next budget cycle by \$80,000 including:
 - a. \$10,000 in filing fees;
 - b. \$55,000 for a paralegal; and
 - c. \$15,000 for a hearing officer.
- 5. Recommend to the Administration to increase the budget of Code Enforcement by \$46,000 during the next budget cycle to hire an administrative position to file the Code Enforcement liens and staff the Vacant Property Review Commission.

Total Budgetary Impact: \$126,000

Next Steps

The Steering Committee is now focusing on the University of Kentucky and the issues with its near neighborhoods including density, noise, trash, crime, parking, transportation, planning, development, neighborhood connectivity, neighborhood stability and demographic balance, transiency, and green space and how best to solve those problems. It supports Planning in its work with the University of Kentucky in monitoring the development of UK Master Plan.

It anticipates that it will next focus on the overall housing needs of the community including how the Vacant Property Review Commission, Land Bank, Community Land Trust, a Community Development Corporation, and an Affordable Housing Trust Fund would work together.
