## IN THE NEWS AND IN THE DISTRICT...

Dear 9th District Neighbors,

First, let me begin this edition by wishing you and yours a very Happy Thanksgiving and a joyous Holiday Season.

Reynolds Road Roundabout Update. A photo of the solar-powered Advance Warning Flashing Beacons that will be installed by Traffic Engineering next spring is shown at right. The signs should aid in alerting motorists to reduce their speed as they approach the Roundabout and will hopefully help to reduce the number of accidents occurring there. I will let you know when I have an actual installation date.

The four new Reynolds Road Sports Fields at Shillito Park were seeded and strawed earlier this fall and a second round of seeding and strawing will occur next spring. Once the fields settle and are well grown, irrigation will be added. The fields should be ready for use by next summer and will surely be popular for soccer and other sports activities.

The LFUCG will conduct **public hearings on Time Warner Cable**'s franchise in Lexington.

The city is currently operating under the existing franchise which dates back more than two decades. See page 3 for further details.

The city is currently reviewing eight separate proposals for the new Senior Citizens Center. Ground breaking is anticipated to occur in late 2014. Stay tuned for future updates.

#### TIME WARNER CABLE PUBLIC HEARINGS

There will be two public hearings regarding the cable television franchise of Time Warner Cable in Lexington.

The purpose is to identify future cable-related community needs and interests and review the performance of Time Warner Cable under its current franchise. All interested parties will be given an opportunity to speak at the hearings.

Public meeting dates are as follows: Monday, Dec. 9 at 6 p.m. in the 2nd Floor Council Chambers at 200 E. Main Street.

A second public hearing will occur on Thursday, Dec. 12 at 6 p.m. at the Beaumont YMCA at 3251 Beaumont Centre Circle.

#### HOME SUMP PUMPS & SEWER SYSTEM

As noted recently in the *Lexington Herald-Leader*, the city is making a new push to alleviate sanitary sewer overflow problems by focusing on residential sump pumps.

For many years, many homes in Lexington were built so that their sump pumps drained into the sanitary sewer system, when the water should have been going into the storm sewer. Under the Private Infiltration & Inflow Elimination Program, the city is reimbursing property owners up to \$3,000 to have a licensed plumber redirect sump pumps that are currently connected to the sanitary sewer.

Under city ordinance, homeowners are required to

allow the city to inspect their property to determine if sump pumps are tied into the sanitary sewer system. The city is making it a priority to go home to home in neighborhoods where there are sanitary sewer problems.

As noted in the newspaper article, the city has already redirected 17 sump pumps in the Harrods Hill neighborhood. Also on the list for inspections are the Turfland Mall and Southland Drive areas, particulary Stratford and Sheridan drives.

## HOME HEATING SAFETY TIPS

According to the National Fire Protection Association, nearly half of all home-heating fires occur during the winter months. However, nearly all of these fires are preventable. The NFPA and the Lexington Fire Department offers these simple home heating safety tips:

- Have your chimney inspected each year and cleaned if necessary. Use a sturdy fireplace screen. Allow ashes to cool before disposing. Dispose of ashes in a metal container.
- Space heaters need space. Keep things that can burn such as paper, bedding or furniture at least 3 feet away from heating equipment.
- Turn portable heaters off when you go to bed or leave the

- Plug power cords only into outlets with sufficient capacity and never into an extension cord. Inspect for cracked or broken plugs or loose connections. Replace before using.
- Install smoke alarms in every bedroom, outside each sleeping area and on every level of the home. Test smoke alarms at least once a month. Install and maintain a carbon monoxide alarm in a central location outside each sleeping area.
- Never use an oven to heat your home.
- Have your HVAC units and systems inspected by a qualified professional.
- Change your furnace filters regularly.

### TURKEY FRYER SAFETY TIPS

The growing popularity of turkey fryers has created a potential for fire and injuries if the fryer is not used correctly. Here are a few simple safety tips:

- Use turkey fryers outdoors a safe distance from buildings and any other combustible materials.
- Always follow manufacturers instructions on the set-up and use of the fryer.
- Inspect the propane tank and all associated tubes and connections to ensure there are no leaks of flammable gas.
- Never use turkey fryers in a garage or on a wooden deck.

- Inspect the propane tank and all associated tubes and connections to ensure there are no leaks of the flammable gas.
- Never leave the fryer unattended and never let children or pets near the fryer even if it is not in use.
   The oil inside the cooking pot can remain dangerously hot hours after use.
- Keep an all-purpose fire extinguisher nearby. Never use water to extinguish a grease fire. If the fire is manageable, use your all-purpose fire extinguisher. If the fire increases, immediately call the fire department for help.
