The Division of Parks and Recreation is requesting Council approval of Pyramide USA, Inc. as a sole source vendor for the purchase of an aquatic climbing wall due to the uniqueness of their equipment.

The AquaClimb "Ascent" (model) uses climbing panels with various 3-dimensional contoured shapes molded in durable easy-care fiberglass with UV-resistant gel-coat finish. Modular frame and panel design allows panels to be relocated and rotated in four orientations to reconfigure the wall and alter the climbing experience for patrons, which is unique to this model.

The Division of Environmental Policy is requesting authorization to upgrade existing building control systems to the Tracer ES platform. The current software, used at the Government Center, Family Care Center and Downtown Arts Center, has an outdated interface which inhibits remote access and diagnostic capabilities.

Tracer ES is compatible with the legacy systems and includes a more intuitive, browser-based interface with advanced diagnostic features. The upgrade will allow multiple users access to building information from any browser on the LFUCG network, expand our capabilities to trend and report equipment diagnostic information and, most importantly, provide a more competitive environment for bidding future building control projects.

The cost of the project is \$26,640.00. Project costs include the software license, installation, integration with three (3) legacy systems and training. The Office of Information Technology has reviewed the scope of work. Funding will be provided by the Energy Improvement Fund.

This is to request authorization to execute a contractual agreement with Art in Motion, Inc. (AIM) to provide funding for a bus shelter restoration project in the Gardenside Shopping Center.

Under the agreement, LFUCG will transfer \$33,500 to Art in Motion (LexArts is the fiscal sponsor of AIM and handles its books) to execute the restoration project. Gardenside Shopping Center will contribute \$5000 to the project as will Lextran. In addition to this, Art in Motion was involved in securing a neighborhood grant that will bring \$2500 to the project. Once the funds are transferred to Art in Motion, it will be the responsibility of AIM to oversee and complete the project no later than December 30, 2014. A memorandum of understanding has been executed between AIM, Lextran, and the Pierson Trapp Company (owners of the center) regarding the project.

The Gardenside Restoration and Art Mural project is to renovate an iconic and historic piece of public transportation infrastructure that was created by private development over sixty years ago located on the corner of Alexandria Dr and Darien Dr. This project is slated to revamp the electric fixtures and related infrastructure, updating it with modern technology (neon to LED) while maintaining congruency with the historic architectural structure that was created in the 1950s. The shelter will be thoroughly cleaned, repaired where needed and painted. A public design contest will be held to determine an art mural which is intended to be implemented on the inside back wall of the shelter.

The LFUCG funds are budgeted (1105 160705 001 90511). Funds for the project were allocated by Council as a part of budgeting of surplus funds in fall 2013.

Environmental Quality Committee January 28th, 2014 Summary and Motions

Council Member Stinnett called the meeting to order at 11:00am. Council Members Gorton, Akers, Farmer, Scutchfield, Myers, Clarke and Henson were present. Council Members Mossotti and Lane were absent. Council Member Kay was present as a non-voting attendee.

1. November 12, 2013 Committee Summary

Motion by Scutchfield to approve the November 12, 2013 committee summary. Seconded by Gorton. Motion passed without dissent.

2. Keep Lexington Beautiful Annual Report

Jim Pendergest provided the Keep Lexington Beautiful annual report to the committee.

Scutchfield asked what the enforcement results were for the new littering law. Pendergest did not know the number. Scutchfield felt it was useful and asked if we could get it. She requested that we track this information going forward.

Farmer commented on the success of the Richmond Rd. clean up and asked what kind of outreach was planned going forward. Pendergest said that had partnered with Lowe's and planned some smaller projects and had assigned a group to work with neighborhoods to give grants for clean up type projects.

Henson commented on the change in the litter law. It gives the government the option of citing as criminal or civil (ex. dump sites - criminal), everyday littering can be civil.

Myers asked if an illegally placed yard sign fit the definition. Jarvis stated that this was a code issue. Myers wants to abate illegally placed yard signs, would this fit under the new state law. Jarvis said we could look at this locally as part of KLB. Myers asked for research on the issue and a report to the committee.

Stinnett asked what the annual budget is for KLB. Pendergest said they are funded by donations and do not currently receive support from the City. Their current annual budget is \$16K.

3. Waste Management Audit Follow Up

Bruce Sahli provided an update on the waste management audit to the committee.

Henson asked Hamilton/Martin how Council could be assured when they get these audits, some of which are alarming, going forward that there will be follow up and things are going to continue to get better. Hamilton stated that the Mayor met with IA quarterly to and his concern is also follow up. He feels that IA needs to go back in to ensure that changes are being made. Hamilton added that they (Administration) need to take these audits and follow up as managers and not just rely on IA to point out when issues have not been addresses or corrected.

Stinnett stated that there many of the items addressed in the audit are the result of communication issues (SOPs are not communicated), how have we corrected communication in the division and how is it working now. Martin stated that there was a leadership change in December and the approach they are taking the approach of trying to eliminate the filters as that seems to be a big part of the communication problem. When they visit they stop in and talk with the front line employees first rather than just go straight to the second floor. He has also reassigned an employee to be located in the Commissioner's office to focus on the standard operating procedures because he didn't create them and would like the opportunity to look at them a little more closely particularly how they relate to what is done in water quality. They are also going to focus on regular ongoing communication rather than issuing a memo.

Clarke asked about uniforms for waste management employees being classified as a benefit and pointed out that the audit findings seem to contradict this stating that uniforms are excluded from wages if they are required for employment (page 14). Sahli stated that it depends on the type of uniform and whether it can be worn outside of the workplace (boots, polo shirts, etc.). This was mentioned to ensure that if there was an IRS requirement that we are following it. Sahli added that he had added a lot more follow ups to the internal audit plan that was approved by the board.

4. Monthly Financials

O'Mara provided an overview of the monthly financials for the sanitary sewer operating fund (4002) and pointed out that the second revenue line (\$6.2M) actually belongs in the next fund (construction fund) and will be corrected. The remaining information is just a snap shot of where we are in the year. Page 47, water quality fund, page 48 newly created construction fund for water quality and landfill is on page 49, all are for the first 6 months thru December 31st. Stinnett asked if there could be a brief comment on the revenues. It appears we are ahead of schedule for the first 6 months on all revenues, are revenues coming in as we projected given the new LexServ bill and the billing system on these three funds. O'Mara said they are in the process of an extensive research and verification of our collection rate. They are vetting the information received by Cincinnati water to be sure it is interpreted correctly and he would like to add this to the agenda for next month to be sure he has the information evaluated properly

before sharing. Stinnett added that it looks like revenues are higher. O'Mara stated that they

are trying to determine why.

Stinnett walked the committee through the referred items list.

Stinnett asked for a report back on the UK game day solid waste collection issue to see if it needs to remain in committee. Stinnett also asked for a report back on the bulky item collection issue. Farmer asked that the committee look at these two issues and see what the revenue sources are before dropping them.

Motion by Myers to remove the division of water quality construction process from the committee referral list. Seconded by Scutchfield. Motion passed without dissent.
