

The following Ordinances were signed by Mayor Jim Gray, attested by Council Clerk Martha Allen and published on October 29, 2015-1t.

Ord 116-2015-An Ordinance amending certain of the Budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures and appropriating and re-appropriating funds, Schedule No. 11. WHEREAS, it is necessary and proper to amend the budgets of the Lexington-Fayette Urban County Government to reflect current requirements for municipal expenditures: NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT: Section 1-That certain of the Budgets of the Lexington-Fayette Urban County Government be and hereby are amended to reflect current requirements for municipal expenditures, and that to effect such Amendments the following appropriations be and hereby are authorized and directed: \$13,706.00 from the Unappropriated Fund Balance in General Services District-General Fund to various accounts. \$75,000.00 to the Unappropriated Fund Balance in Full Urban Services District Fund from various accounts. \$2,434,759.89 to the Unappropriated Fund Balance in Refunding GO Bond 2015A from various accounts. Re-appropriations within the General Service District – General Fund; Donation Fund; General Fund Capital Projects; and the various grant funds that do not result in changes to the Unappropriated Fund Balance of these funds. Section 2-That the purposes of the Budget Amendments and the Accounts to or from which funds are herein appropriated, are detailed in “BUDGET SCHEDULE NO. 0011” attached hereto and incorporated herein by reference. Section 3-That this Ordinance shall become effective on the date of its passage. PASSED URBAN COUNTY COUNCIL: October 22, 2015

Ord 117-2015-An Ordinance amending Section 2-19 (1) of the Code of Ordinances, deleting the requirement that the Clerk of the Urban County Council administer the oath of office to board, agency, and commission appointees and extending the time required to complete and submit the oath of office by affidavit PASSED URBAN COUNTY COUNCIL: October 22, 2015

Ord 118-2015-An Ordinance amending Sections 7-39 and 12-81 of the Code of Ordinances, amending the definition of abandoned urban property and blighted or deteriorated property PASSED URBAN COUNTY COUNCIL: October 22, 2015

Ord 119-2015-An Ordinance closing Barkley St; determining that the property owner abutting the street to be closed has been identified, provided with written notice of the proposed closing, and consented thereto in writing; and authorizing the Mayor, on behalf of the Urban County Government, to execute a Quitclaim Deed and any other documents necessary to transfer the former right-of-way to the abutting owner, subject to the reservation of easements and restrictions PASSED URBAN COUNTY COUNCIL October 22, 2015
