Commander David Lyons, Div. of Police, presented a police disciplinary recommendation regarding Officer Jordan Truett. It is alleged that Officer Truett has committed the offense of Misconduct and Violating Any Rules of the Division: Restraining Devices, Transport Operations & Transport Equipment, in violation of KRS 95.450 and G.O. 1973-2/I, Section 1.02, and G.O. 1992-16D, Section 1.35, Section IV

Procedures A, 1, 2, 4, 5; D, 1, 2 & B 1, 20 in that on the 16th day of August 2015, Officer Truett arrested a subject in response to a dispatch call for service. His actions while handling the call and once the subject was arrested did not reflect favorably on him or the Department. When Officer Truett arrested the subject, he failed to place handcuffs on the arrestee at the scene and while transporting the arrestee to the Detention Center. He also did not properly search the arrestee and subsequently transported and booked the unsearched arrestee into the Detention Center. During the transport, Officer Truett also failed to utilize the Department-installed safety barrier properly and the appropriate punishment for this conduct is two months suspension without pay for violation of G.O. 1973-2/I, Section 1.02, Misconduct – and – 40 hours suspension without pay (combined suspension without pay of 9 weeks) for violation of G.O. 1973-2/I, Section 1.35 – Violating Any Rules of the Division. Officer Truett is also to be scheduled for re-training (Prisoner Security & Transportation).

Upon motion by Mr. Farmer, seconded by Ms. Henson, and approved by unanimous vote, the disciplinary recommendation was approved.

Commander Lyons presented a police disciplinary recommendation regarding Officer Joseph Felinski. It is alleged that Officer Felinski has committed the offense of Misconduct in violation of KRS 95.450 and G.O. 1973-2/I, Section 1.02, in that on the 23rd day of August 2015, Officer Felinski conducted a stop for a traffic violation utilizing his Lexington Police cruiser while off duty in Scott County. On August 24, 2015, at approximately 1800 hours, Officer Felinski attended a Georgetown City Council meeting. Officer Felinski represented himself as a Lexington Police Officer while making a presentation in reference to a neighborhood complaint for the Georgetown City Council. Officer Felinski stated he was a Lexington Police Officer and wore a polo shirt with an embroidered Police Department badge and displayed his police badge, gun, and handcuff/ammunition pouch on his belt and the appropriate punishment for this conduct is One Hundred Sixty (160) Hours Suspension Without Pay (30 Days), Sixty (60) Day Home Fleet Suspension (after serving 160 hours suspension), and retraining on officer authority, civil liability, application and decision making. Officer Felinski may use his vehicle for off-duty employment.

Upon motion by Mr. Farmer, seconded by Ms. Henson, and approved by unanimous vote, the disciplinary recommendation was approved.

Commander Lyons presented a police disciplinary recommendation regarding Officer James Jeffries. It is alleged Officer Jeffries has committed the offense of Misconduct in violation of KRS 95.450 and G.O. 1973-2/I, Section 1.02 in that on the 11th day of September, 2015 Officer Jeffries was advised of a possible crime that occurred in Scott County involving a juvenile and went, that same day, to interview the juvenile suspect out of his jurisdiction. On September 10, 2015, a juvenile's mother heard rumors about her daughter possibly being a victim of a crime. A report was filed in Scott County on September 10, 2015 and assigned to a Detective with Georgetown Police Department on September 11, 2015. Detective Jeffries also initiated contact with the parents of both juveniles in Scott County. Detective Jeffries did not immediately notify Scott County with his knowledge prior to or after conducting an interview. Detective Jeffries's actions intervened with an active case in Scott County and did not reflect favorably on him or the Lexington Police Department and the appropriate punishment for this conduct is a Written Reprimand.

Upon motion by Mr. Farmer, seconded by Mr. Hensley, and approved by unanimous vote, the disciplinary recommendation was approved.
