- G. Authorization to Execute an Engineering Services Agreement with Strand Associates, Inc. for the Feasibility Study and Engineering Design of the Legacy Trail Project. (525-08) (P. King/Webb) This request will authorize the execution of an Engineering Services Agreement in the amount of \$496,000 with Strand Associates, Inc. for the feasibility study and engineering design of the Legacy Trail Project. Federal funds from the Kentucky Transportation Cabinet have been awarded for two (2) sections of this Trail. Authorization to Submit an Application to the Kentucky Justice Cabinet and Accept the Award (if Offered) for the Violence Against Women Act Program for the Continuation of the Sexual Assault Nurse Examiner (SANE) Program – FY2009. (514-08) (P. King/Bennett)

This request will authorize the submission of an application for federal funds in the amount of \$67,570 to the Kentucky Justice Cabinet under the Violence Against Women Act Program for the continuation of the SANE Program within the Division of Police as a response to sexual assault for females 14 years old and above. A local match of 25% (\$23,190) is required and is budgeted in the Division of Police's FY2009 General Fund budget. Total costs for a 12-month period will be \$116,910. Funds are also requested for purchase of a new colposcope in the amount of \$29,000. It is projected that as many as 130 sexual assault examinations will be conducted during this period. It is estimated the SANE Manager will perform approximately 25 examines and the remaining 105 will be performed by a SANEs under contract with LFUCG. It is anticipated the state's Crime Victims Compensation Fund will pay \$200 for each exam for an estimated total of state revenue of \$21,000. LFUCG pays the nurses \$230 per examine. The remaining \$30 per examine (\$3,150) is budgeted as a grant match in the Division of Police's FY2009 General Fund budget.pp.32-33

Ellinger had a question about item G of New Business which refers to the living wage and was told by Michael Allen, HR Director, 17 employees have been identified to receive the living wage.

Motion by DeCamp to approve new business items, seconded by Gorton, motion passed.

Down Syndrome Awareness and Buddy Walk Day Proclamation

Mayor Newberry declared Saturday, September 27, 2008 as the 6th Annual Buddy Walk Day to be held a Keeneland Race Track at 9:30 am

Intergovernmental Committee update by James, with one motion coming forward:

Motion by James for building inspection to provide a list of business affected by the temporary structure proposal and to notify those business that have received a temporary structure permit in the last three (3) years to attend the November 2008 Intergovernmental Committee Meeting, seconded by Stinnett, motion passed.

Stevens asked James if the intent was to add the motion as an ordinance and be placed on the work session agenda. Myers asked if the work of the committee was completed yet on this issue. There was much discussion regarding findings with several questions, observations and recommendations from council members. Council member Blues asked for hard copies of the presentation. Mr. Osborne agreed to provide.

Council Report

McChord announced the Metropolitan Planning Organization meeting at 6:30 pm that evening at Southland Christian Church. He congratulated Div. of Police and officers recognized at the recent awards banquet. He also announced the Second Sunday Event to be held from 2:00 – 6:00 pm in October. South Lime Street will be closed during those hours fro people to walk, bike ride, etc.

James asked McChord if any business owners along that route should have questions about the event who they should address them to. McChord recommended calling the Shaye Rabold, in the Mayor's Office.

Stinnett announced an Eastland Parkway Neighborhood Assoc. meeting and encouraged the public to attend since the high school property issue will be discussed. He also shared details of his recent visit to Larry Roberts's office and said he plans to coordinate a group visit including council members for a Wednesday morning at approx. 10:00 am. James also commented on her visit and observations made. He referred to the second TIF project that was walked on to the docket and was concerned about each TIF project request being treated differently. He wanted to know if there was a process or outline identified in preparation for the upcoming TIF public hearings. He asked the Mayor to direct the TIF hearings be broadcasted on GTV3.

Lane commented on his recent visit to the Horse Park stating he was very impressed and commended them on a flawless organization.

Blues announced the Spicewood Neighborhood Assoc. meeting and also encouraged public participation in the Bryan Station High School discussion previously referred to by Stinnett.

A motion by Myers to approve the NDF list dated September 23, 2008, seconded by Gorton, motion passed.

Myers also had a question about the sign ordinance and was told by DeCamp that motion and request for an ordinance had already been placed in the Services Committee. Myers asked the Services Committee chair if the issue might be placed on the agenda for the next meeting.

Motion by McChord to direct the TIF Delegation to create a project summary, list of standards that would be presented prior to any public hearing. The summary would include" timeframes & costing, general statement of finance, if or how much public money required upfront, track record/performance history of developer, seconded by Lane, motion passed.

Gray indicated he would like to discuss the motion before voting and suggested the TIF Delegation review, evaluate and determine the attributes of a report from Laura Daugherty.

Blevins also commented about the need for a basic list of standards since there have been not one but two TIF applications brought forward. He did not wish to slow the process of those, but stated beyond those, there was a need for a process, standards, etc.

Stevens talked about why the TIF Task Force Delegation was created and the intent and expectations for it.

Beard reminded the council of the time line starting with the first TIF meeting, July 17, 2008 and pressure to get things done with legislation in Frankfort. He said approx. 80% of the TIF process in dictated by state government and not by LFUCG.

James did not agree with the decision for a project summary and list of standards coming from the TIF Delegation but would rather see the matter in a council committee.



Loch Lomond Capital Stormwater Improvement Project

Stantec Consulting Services Inc. (Stantec) was contracted by the Lexington-Fayette Urban County Government (LFUCG) to analyze and design stormwater improvements along Loch Lomond Drive (Purchase Order LF00032501, dated January 11, 2008). The purpose of this letter is to request a change order in the amount of \$7,340.00 for additional work requested by LFUCG. The additional items described below were not included in the original scope of work, were identified during preliminary analyses on the project, and are required to complete the project. A description of the work being requested and the estimated fee associated with completing each task are provided below.

- 1. Wilson Downing Roadway Drainage Improvements. During site reconnaissance and resident interviews, it was identified that the existing drainage channel along the south side of Wilson Downing Road is not functioning properly, resulting in uncontrolled stormwater runoff across Wilson Downing Road to the Loch Lomond project area. Work on this task would expand the Loch Lomond stormwater improvements project area to include the portion of the south side of Wilson Downing Road identified in Attachment #1. Specifically, the work would include performing a topographic survey, hydrologic and hydraulic analysis, engineering design of stormwater improvements, and incorporating recommended improvements into the Loch Lomond design drawings. The estimated fee associated with this task is \$5,970.00.
- 2. Field Survey Sanitary Sewer System in Project Area. Record drawings showing pipe invert elevations for the existing sanitary sewer system within the Loch Lomond project area are unavailable from LFUCG. Sanitary sewer elevation information is necessary to verify that proposed stormwater improvements do not adversely impact the sanitary sewer system. Work under this task would consist of field surveying incoming and outgoing pipe inverts at the ten (10) sanitary sewer manholes within the Loch Lomond project area (Attachment #1). Invert elevation information would be provided to LFUCG for incorporation into their Geographic Information System (GIS) and displayed, as appropriate, on design drawing for the Loch Lomond stormwater improvements. The estimated fee associated with this task is \$1,370.00.

PURCHASE OF SERVICE AGREEMENT

THIS PURCHASE OF SERVICE AGREEMENT, made and entered into on the day of _______, 2008, by and between the LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT, an urban county government of the COMMONWEALTH OF KENTUCKY created pursuant to KRS chapter 67A ("Government"), 200 East Main Street, Lexington, Kentucky 40507, and KENTUCKY WORLD TRADE CENTER LEXINGTON, INC., a Kentucky non-stock, non-profit organization, ("Organization") with offices located at 1600 World Trade Center, 333 West Vine Street, Lexington, Kentucky 40507.

WITNESSETH

That for and in consideration of the mutual promises and covenants herein expressed, the Government and the Organization agree as follows:

- 1. Government hereby retains Organization for the period beginning on July 1, 2008, and continuing for a period of twelve (12) months from that date unless within that period Government gives the Organization thirty (30) days written notice of termination of this Agreement in which case this Agreement shall terminate thirty (30) days from the date notice is given to the Organization.
- 2. Government shall pay the Organization the sum of One Hundred Fifteen Thousand Dollars (\$115,000.00) for services required by this Agreement, the payment schedule for which shall be mutually agreed between the parties.
- 3. The Organization agrees to provide the following services:
- A. Manage and operate the World Trade Center franchise in Lexington, Kentucky;

- B. Provide other such services to include, but not be limited to, trade promotion, trade counseling, trade assistance, seminars, library services to assist Kentucky businesses interested in exporting to foreign countries or otherwise doing business overseas and to assist foreign companies seeking business opportunities in Kentucky;
- C. Submit an annual report each year to the Mayor and the Urban County

 Council, which report shall contain a summary of its activities for the preceding year.
- D. File all federal, state and local tax returns which are required by the respective governmental unit and to submit copies of same to the Department of Finance and Administration ("Department")
- 4. In the event of termination of this Agreement by Government as provided for in Paragraph 1 above, Organization shall be entitled to that portion of total compensation due under this Agreement, or renewals thereof, as the service rendered bears to the service required hereunder.
- 5. Organization shall perform all duties and services described in item 3 above faithfully and satisfactorily at the time, place and for the duration prescribed herein. Organization shall keep itself fully informed of all national and state laws and all municipal ordinances and regulations in any manner affecting the work or performances of this Agreement, and shall at all times observe and comply with such laws, ordinances and regulations, whether or not such laws, ordinances or regulations are mentioned herein and shall indemnify Government, its officers, agents and employees against any claim or liability arising from and based on Organization's violation of any such laws, ordinances or regulations.

- 6. Organization represents that it has filed any federal, state or local income tax returns required by law in the legally prescribed time and manner for the preceding fiscal year. This Agreement shall not become effective unless and until copies of all of the executed originals of the aforementioned tax returns filed for the Organization have been registered by the Organization in the office of the Commissioner of the Department, and the Organization shall not be compensated unless and until such registration has taken place.
- 7. Books of accounts shall be kept by the Organization and entries shall be made therein of all money, goods, effects, debts, sales, purchases, receipts, payments and any other transactions of the Organization. The books of accounts, together with all bonds, notes, bills, letters and other writings belonging to the Organization, shall be maintained at the principal place of business of the Organization as set forth in this Agreement. Government shall have free and complete access to the books papers and affairs of the Organization at all reasonable times, and if it desires, it may have the books and papers of the Organization audited and examined by auditors, accountants or attorneys. Any examination shall be at the expense of the Government.
- 8. Government may designate such persons as may be necessary to monitor and evaluate the services rendered by the Organization. The Government, its agents and employees, shall, at all times, have unrestricted access to all places where or in which the services required hereunder are being carried on and conducted. Inspection and monitoring of the work by these authorities shall in no manner be presumed to relieve in

any degree the responsibility or obligations of Organization, or to constitute Organization an agent of the Government.

- 9. Organization shall provide equal opportunity in employment for all qualified persons, shall prohibit discrimination in employment because of race, color, creed, national origin, sex, age, sexual orientation or gender identity, or handicap, shall promote equal employment through a positive, continuing program of equal employment, and shall cause each of its subcontracting agencies to do so. This program of equal employment opportunity shall apply to every aspect of its employment policies and practices.
- a minimum, contain a statement of current law; a list of prohibited behaviors; a complaint process; and a procedure which provides for a confidential investigation of all complaints. The policy shall be given to all employees and clients and shall be posted at all locations where Organization conducts business. The policy shall be submitted to the Department of Law for review within thirty (30) days of the execution of this Agreement.
- 11. The Organization agrees that all revenue and expenditures shall be audited at least annually by independent certified public accountants who shall express an opinion as to whether or not revenue and expenditures during the year audited have conformed with state and local law and regulation.

This instrument contains the entire agreement between the parties, and no statement, promises or inducements made by either party or agent of either party that is not contained in this written Agreement shall be valid and binding; and this Agreement may not be enlarged, modified or altered except in writing signed by the parties and endorsed hereon.

The Lexington-Fayette Urban County Government annually receives federal funds for operation of its mobility office (Ridesharing program), funded from the Surface Transportation Program-Lexington (SLX) and operated by the Division of Planning. Acceptance of these funds for Fiscal Year 2009 was approved by Council on May 22, 2008 (Ordinance # 108-2008).

The approved grant project provides for the design and implementation of a marketing campaign that will increase the public's awareness of air quality issues and encourage the use of transportation alternatives. The ultimate goal of the air quality program is to ensure air quality conformity in accordance with the state of Kentucky's implementation plan. In addition to contract award in Fiscal Year 2009, the RFP provides for a one-year renewal in Fiscal Year 2010, pending agreement by both parties and availability of funding. The Agreement in the amount of \$40,400 with Ad-Success includes design, television and radio time, print materials, and documentation of Public Service Announcements.

TRAIL PROJECT—RFP 28-2008

In response to RFP 28-2008, ten proposals were received for the feasibility study and engineering design of the Legacy Trail Project. Three firms were invited to make presentations to the selection committee made up of representatives from Urban County Council, University of Kentucky, citizens, Mayor's Office, and the Divisions of Planning and Engineering. Strand Associates, Inc. was selected as the firm that most nearly met the selection criteria.

The Legacy Trail is a shared-use greenway trail that will connect downtown Lexington with area neighborhoods, parks, and historic sites as it follows a northward course to the Kentucky Horse Park. The LFUCG has been awarded federal funds from the Kentucky Transportation Cabinet for two sections of this trail. The Maine Chance Trail is funded from the Congestion Mitigation Air Quality (CMAQ) program and the Coldstream Park Trail is funded from the Transportation Enhancement program. This agreement includes feasibility study and development of construction documents for these two sections. The feasibility study will also include planning documents for the remaining two sections: Lexmark Section and Downtown Section. Funds for the feasibility study will come from bond revenue funds generated for trail development.

The Division of Police has prepared an application for submission to the Kentucky Justice Cabinet requesting federal funds in the amount of \$69,570 from the U.S. Department of Justice/Violence Against Women Act (VAWA) Program for the continuation of a Sexual Assault Nurse Examiner (S.A.N.E.) program in the Division of Police as a response to sexual assault for females fourteen and above. The Division of Police, the Commonwealth Attorney's Office, the Fayette County Attorney's Office, and the Bluegrass Rape Crisis Center have collaborated on the planning and implementation of this project and have agreed to provide a coordinated response to the victims of sexual assault.

This project was begun in 2000 with the creation and filling of a full-time position of S.A.N.E. Manager as a civilian employee in the Division of Police. Other S.A.N.E.s have been recruited to serve on-call on a contractual basis. S.A.N.E.s are registered nurses with specific credentials for the examination of rape and other sexual assault victims. The University of Kentucky Medical Center provides private examination and waiting space in its Emergency Room for this program. Dr. Lee Irwin, emergency room physician, serves as medical director for the project. The purpose of this project is to provide the victims of sexual assault with better examinations for evidence and to give greater care to the chain of evidence with the objective of more successful prosecutions for sexual assault. It is anticipated that more humane treatment of the victim at the time of the examination will increase reporting and increase willingness to testify in prosecutions.

Total project costs for a 12-month period will be \$116,910. Of this total, the request for federal funding is \$69,570, requiring a 25% local match in the amount of \$23,190 which is budgeted in the Division of Police's FY 2009 general fund budget. Funds will be used for contractual

services, emergency room space, medication costs, cell phone, pagers, professional training for additional Sexual Assault Nurse Examiners to serve "on-call," and supply and equipment costs. Funds are requested for purchase of a new colposcope in the amount of \$29,000. It is projected that during a full project year, as many as 130 sexual assault examinations will be conducted. It is estimated that the S.A.N.E. Manager will perform approximately 25 of these exams in the course of her work. The remaining 105 exams will be performed by S.A.N.E.s working under contract. It is anticipated that the state's Crime Victims Compensation Fund will pay \$200 for each of these exams, for a total estimated state revenue of \$21,000. The LFUCG pays the nurses at a rate of \$230. The remaining \$30 per exam (\$3,150 total) is also budgeted as grant match in the Division of Police 2009 general fund budget.

SYSTEM

On June 26, 2008 (Resolution No. 365-2008), Council approved the submission of an application to the Kentucky Office of Homeland Security for the expansion of the Central Kentucky 9-1-1 network to include additional jurisdictions. The goal is to create a redundant infrastructure allowing simplified network connectivity, lower cost and more efficient operations for all parties involved. The regional system will accept landline, wireless and VoIP emergency calls and fully transfer all voice and data associated with each call; capabilities not currently available between individual communication centers.

The Kentucky Office of 911 Coordinator/Commercial Mobile Radio Service Board has offered the Lexington Fayette Urban County Government \$177,015 in state funds for purchase of equipment and services necessary for the acquisition, installation and implementation of Next Generation 911 infrastructure to Public Service Answering Points in Boyd, Casey, Garrard, Lincoln, Rockcastle and Taylor Counties. No local match is required.

Council authorization to accept the award is hereby requested.
