- 6. Information Booths: applicants will not vend any materials or merchandise during the event. Only informational materials may be dispensed, at no charge, to the public or any consumer during the event.

7. Arts & Crafts Vendors: All products, merchandise or information offered should be relevant to the Irish/Celtic culture.

Applicant must submit a description of items to be offered (pictures are acceptable) with the registration application.

The St. Patrick's Festival reserves the right to prohibit vendors from selling items that do not meet these requirements.

8. Artists and crafts people selling their own products must be displayed in an Irish/Celtic manner.
