Meeting Summary

- 1. Welcome & Introductions
- 2. Approval of Committee Summary from September 11th, 2019 Meeting
 - Approved after a motions by Kenny Bishop and seconded by CM Susan Lamb
- 3. Committee Goals & Priorities
 - Establish a goal rate to improve on that of 2010, which was mail response only, 2020 will have new methods: mail, phone, and internet response.
 - Establish a knowledge in the community and clear in our messaging that each household needs to respond and that a household doesn't have to be a house—is also a shared apartment, dorm, etc.
 - Each household will receive a mailing with their unique passcode to complete the questionnaire online or over the phone.
 - Passcodes will be mailed March 12, 2020, and will have 4 follow up mailings, if not completed online or by mail:

March 12-20

March 16-24

March 26-April 3

April 8-16

April 20-27

- The in-person follow ups will begin in Mid-May
- Households can still call in, even if they have not received the mailing with their passcode (which will be mailed to each household & needed to complete the online questionnaire)
- Dustin Baker talked about the return rate versus the response rate, noting the return rate removed the vacant, deleted, and undeliverable addresses.
- Lexington had a 79.6% return rate for the 2017 American Community Survey (ACS)
- Will research how those return & response rated compare to other comparable communities.
- WeCountLex will emphasize all three response options to complete the questionnaire.
- Where possible in the community, clear up misconceptions that the 2019
 American Community Survey (ACS) happening currently is NOT the 2020 Census.
- At our January meeting, we will focus on language barriers & privacy (especially online), including the problem of not enough languages in the phone help.
