 - The local Area Census Office (ACO) reported on the task of recruiting Census workers, and the issues they're having meeting their goals.
 - As of now, the ACO has only had a 48% response rate of where they need to be in recruiting workers.
 - The hourly rate has increased to \$19

 - Need more visual data to make people want to take the Census
 - Meetings at Global Lex January 15th and 25th with community leaders & on a constant basis
