Sir,

This memorandum will provide a summary of the investigation into the Formal Complaint filed on by Mr. Daniel Spilling alleging improper conduct by Det. Steve Cobb. According to the Formal Complaint, Detective Cobb, when filing a criminal complaint against Mr. Spilling, left out exculpatory information. Mr. Spilling alleged that Det. Cobb misled the Fayette County Attorney's Office and the Court in order to "get [Mr. Spilling] arrested."

If the above allegations are true, Detective S. Cobb is in violation of General Order 1973-02K, Disciplinary Procedures, Appendix B, Operational Rule 1.02--Misconduct:

Officers shall conduct themselves at all times, both on and off duty, in such a a manner as to reflect most favorably on the department and to not cast doubt on the officer's integrity, honesty, judgement, or character. Misconduct of an officer shall include that which tends to bring the department into disrepute or reflects discredit upon the officer as an employee of the department, or that which tends to impair the operation and efficiency of the department or officer.

Investigation

Mr. Spilling has a significant history of issues with his neighbor and what he believes is an inadequate response by the Police Department. He has expressed his frustration multiple times, including an informal complaint filed against Det. Cobb on April 4th, 2021. Sgt. Merker reviewed the informal complaint and found it to be without merit. The informal complaint was unfounded and documented via a BlueTeam report. After the informal complaint was unfounded, Mr. Spilling filed a formal complaint against Det. Cobb; I have reviewed the informal complaint and concur with Sgt. Merker's conclusion.

On May 21st, 2021 at approximately 1330, I spoke with Mr. Spilling by phone to clarify his complaint on Det. Cobb. Mr. Spilling agreed that his complaint on Det. Cobb is composed of two points:

• Det. Cobb, in the criminal complaint that he filed with the Fayette County Attorney's Office, omitted exculpatory information that would have led to the County Attorney's Office not approving the complaint. According to Mr. Spilling, Det. Cobb did not sufficiently add context to Mr. Spilling's words, neglecting to state that Mr. Spilling would only take action if the opposing party came onto his property.

• Det. Cobb intentionally omitted the exculpatory language, committing perjury "by omission".

Following the receipt of the Formal Complaint and the conversation with Mr. Spilling, I reviewed both allegations. Additionally, Mr. Spilling demanded that when reviewing his complaints against Det. Cobb, I also take into account the entirety of his and his mother's interactions with and the activities that occurred at residence. Pursuant to Mr. Spilling's request, I reviewed a file folder that he submitted with his formal complaint as well as a jump drive that he submitted that included video and audio files; I reviewed all of the submitted information.

The information submitted by Mr. Spilling shows significant issues that occurred between him and his former neighbor,

Throughout his interactions with law enforcement, Mr. Spilling was understandably frustrated. During the course of his issues with his neighbor, Mr. Spilling had substantial contact with law enforcement that included numerous emails to (retired) Commander David Lyons and Det. Cobb.

On 05/22/2018, Det. Cobb submitted a criminal complaint against Mr. Spilling for the charge of Terroristic Threatening Third Degree. The complaint was reviewed by Amy Thurman and Jennifer Wade of the Fayette County Attorney's Office on 05/23/2018; a warrant was issued for Mr. Spilling's arrest by Judge Bouvier on 05/23/2018 at 14:34. The warrant for arrest was served at 19:28 by Officer Heiner of the Lexington Police Department.

Allegation 1: Det. Cobb omitted exculpatory information:

Mr. Spilling contends Det. Cobb did not convey the totality of the circumstances between Mr. Spilling and his neighbor; specifically, alleging Det. Cobb misled the court by portraying Mr. Spilling as someone who was looking to initiate conflict, as opposed to someone expressing a desire to defend himself. Mr. Spilling argues that Det. Cobb did not include "comes into our yard" in the language in the criminal complaint, thereby hiding Mr. Spilling's self-defense interests.

In Det. Cobb's criminal complaint, he includes language from an email sent to (retired) Commander Lyons by Mr. Spilling on April 16th, 2018:

got me a gun, he scares my mother again by touching one blade of our grass, only one way to look at it, he is coming to make good on threats. We will let the people of Lexington decide and the state and nation can make up their mind. I really can't believe this might turn Lexington into the next city of racial unrest. O well. I have had enough.

In this email, Mr. Spilling states "one blade of our grass"; this supports a reasonable inference that Mr. Spilling is referencing someone coming into his yard.

Additionally, Det. Cobb submitted the entire texts of multiple email conversations between Mr. Spilling Det. Cobb and Commander Lyons. In several of the emails submitted to the FCAO that were also available for review by Judge Bouvier, Mr. Spilling qualifies his threats as being contingent on Mr. Sparks crossing his property boundaries. Also, the Fayette County Attorney's Office was familiar with Mr. Spilling from the multiple issues he was having with his neighbor.

I have reviewed the submitted criminal complaint, the supporting documentation, and spoken with Fayette County Assistant Attorney Jason Rothrock. It is my opinion that Det. Cobb submitted sufficient information for Judge Bouvier to make an informed, unbiased decision.

Allegation 2: Det. Cobb committed perjury:

Mr. Spilling contends that by not including exculpatory information, Det. Cobb committed perjury "from omission". Perjury requires a false statement under oath. Perjury by omission is not a crime.

Conclusion

Having reviewed Mr. Spilling's allegations, the information submitted by Mr. Spilling, and the relevant court filings, I do not believe that Det. Cobb mischaracterized the nature of Mr. Spilling's statements.

When ever 78 year-old mother was outside he would walk his pit bull from the sidewalk, allowing pit bull ten feet into yard, scaring an already scared elderly lady. Called police, no report taken. I came home on 05/20/18 to a 78 year-old lady in tears and shaking in fear.
