



# 2022-2023 Emergency Winter Weather Plan

*This version is current as of 10/12/2022.*

### **Background**

Every year, the Lexington-Fayette County Homeless Response System meets and plans for all potential emergency shelter needs of those experiencing homelessness. This provides a coordinated response for times when extreme cold weather creates additional, immediate need for expanded capacity to assist those experiencing homelessness in Lexington.

### **Community response**

The Emergency Winter Weather Plan will be activated when measures of extreme temperatures are reached or when other severe weather conditions take place. Extreme temperature will be defined as:

- Any day/night when the temperature low is expected to fall below 32 degrees

The wind chill will not be taken into account in the determining temperature. Decisions about severe weather that takes place on days outside of extreme temperature situations will be made by the Office of Homelessness Prevention and Intervention in consultation with the appropriate authorities

Any time the plan has been activated, the Office of Homelessness will notify local media, provide updates on social media, and notify all organizations that work with people experiencing homelessness.

### **Emergency day centers**

Emergency day centers welcome all eligible people during emergency winter weather including former participants under suspension for behavioral or programmatic reasons.

Exceptions may include individuals suspended for violence and decisions will be made case-by-case. The OHPI will collaborate with providers and other resources to ensure emergency day shelter is available for anyone in need. ### **Emergency overnight shelters**

Emergency night shelters welcome all eligible people during emergency winter weather including former residents under suspension for behavioral or programmatic reasons provided shelter has open space.

Exceptions may include individuals suspended for violence and decisions will be made case-by-case. The OHPI will collaborate with providers and other resources to ensure emergency shelter is available for anyone in need. ### **2022-2023 Winter Overnight Emergency Shelter Capacity**

#### **Arbor Youth Services**

Arbor Youth Services will continue to operate their emergency shelter with no extended capacity during the winter. Data shows that capacity for their birth to 17 years of age shelter will be sufficient as currently operating.

Arbor Youth Services will continue to operate their new emergency shelter with no extended capacity during the winter for unsheltered youth 18-24 years of age.

#### **Catholic Action Center**

The Catholic Action Center remains at reduced capacity due to COVID-19, adjusting to 102 beds on a regular basis.

New residents are currently being accepted on a case-by-case basis only. Completion of a COVID-19 test is required prior to entry; testing occurs onsite, but arrangements for date/time must be made with shelter staff in advance.

**Hope Center**

The Hope Center has increased capacity in their shelter building back to 160 beds on an average night, with an ability to expand to 200 beds by utilizing areas within their building, like their basement, to add mats while still allowing for social distancing. The Hope Center also retains sleeper trailers with an additional 28 beds to expand capacity as needed. All individuals will be provided case management and referral services including offers of permanent housing while in the shelter.

**The Salvation Army**

The Salvation Army is a congregate shelter within Fayette County that is able to provide overnight emergency shelter for single adult women, single mothers with children, and single fathers with children. All individuals will be provided case management and referral services including offers of permanent housing while in the shelter.

The Salvation Army will make arrangements within their facility located at 736 West Main Street, including the use of their lobby, hallways, and TV lounge to accommodate those seeking shelter on cold nights. Individuals seeking shelter under this warming shelter model will not receive case management or service referrals.

**2022-2023 Winter Day Shelter**

During the winter months, day time temperatures can remain under 32 degrees. The Lexington-Fayette County Continuum of Care recognizes that it is important not to only provide overnight shelter, but places that individuals and families can seek shelter during the day.

**2022-2023 Winter Transportation and Street Outreach Services**

Individuals and families without homes rarely have personal, reliable transportation. Many walk miles and miles a day just to access basic needs. With the weather turning colder, we recognize as a community that individuals that are already vulnerable are not able to walk those miles in the cold. We also recognize that some individuals do not have access to up-to-date weather reports to understand how cold it may become during the night. We also know that frost bite is the No. 1 discharge diagnosis to medical respite during the winter.

Due to these factors, the community partners will facilitate transportation to shelter. Catholic Action Center will operate the Compassionate Caravan during extreme cold temperatures. Additionally, street outreach teams can help facilitate referrals and transportation to shelter.

### **Donations for Winter Weather**

Donations to providers always play a crucial role in winter weather response. Every provider accepts basic needs supplies that are so important to those without homes. Below are some general donations that are always needed. Public donations can be given to a participating agencies; however, the public is required to call for donation policies and processes for each agency.

- Blankets
- Hats
- Winter boots/shoes
- Winter coats, especially size L, XL and XXL
- Gloves
- Socks
- Scarves
- Hot Hands
- COVID-19 test kits
- Sleeping bags
- Sweatshirts/hoodies (adult men and women)
- Bottled water
- Individually packaged snacks
