They will measure their success by whether they prevent retaliation and re-injury with survivors of gunshots and stabbings. For those individuals and households who are at high-risk of violence but have not yet been involved in an incident, we will measure success by whether we prevent participation in a violent crime or being injured by gunshot or stabbings. Through June 30, 2023, the funding has assisted 94 households.

Entering a recovery residence provides the support and structure crucial to recover from substance use disorder. It provides a balance of drug-free support, accountability to peers and an opportunity to live in a safe, affordable, sober environment at a critical time in a person's recovery journey. RSLA provides up to \$400.00 to in assistance to individuals continuing in or entering a recovery residence. Typically, recovery residences charge between \$100 and \$125.00 per week. This fee includes a bedroom, shared access to common areas (kitchen, bathroom, family room, etc.) and utilities. While each residence has its own guidelines, most include a minimum number of mutual support meetings per week, random drug testing, house meetings and alternating chores. Entering a recovery residence provides the support and structure crucial to recover from substance use disorder. It provides a balance of drug-free support, accountability to peers and an opportunity to live in a safe, affordable, sober environment at a critical time in a person's recovery journey. RSLA provides up to \$400.00 in assistance to individuals continuing in or entering a recovery residence. Typically, recovery residences charge between \$100 and \$125 per week. This fee includes a bedroom, shared access to common areas (kitchen, bathroom, family room, etc.) and utilities. While each residence has its own guidelines, most include a minimum number of mutual support meetings per week, random drug testing, house meetings and alternating chores.
