Youth Services

COMMUNITY CASE MANAGEMENT

Social workers connect families to resources through case management services for youth. These youth are referred by parents/guardians, community agencies and schools. This service is voluntary.

COURT CASE MANAGEMENT

Social workers provide intensive case management services for youth referred by Family Court for the status offenses of: habitual truancy, habitual runaway and/or beyond control of parent or school. This service is court ordered and participation is mandatory.

SUBSTANCE USE OUTPATIENT AND CASE MANAGEMENT SERVICES

Individual and group therapy services focused on substance use harm reduction. Substance Use assessments are completed to support clinical diagnoses, treatment planning, performance monitoring, program planning and placement recommendations for the success of our youth and to empower their families.

YOUTH EMPOWERMENT WORKSHOPS

PAGE offers youth workshops that provide the skills needed to build character traits and empower youth to make positive and healthy decisions.

AFTER CARE SERVICES

PAGE offers all previous Division of Youth Services clients; continued after care and support services once they have completed their previous programming. The individual is **not** required to be successful in previous Youth Services' programs. Requirements:

1. The youth must be age 12-21.
2. Seeking assistance with continued education, independent living or employment needs.

OUR VISION

The services we offer are designed to strengthen family life, prevent family breakdown and facilitate the development and social functioning of young people.

OUR MISSION

To provide Fayette County youth under the age of 18 who are navigating their adolescent years and their families with specialized case management services.

PARENT AND GUARDIAN EMPOWERMENT (PAGE)

PAGE works with youth and their families living in Fayette County. Our program strives to empower parent/guardians to gain the skills and confidence needed to guide and inspire their youth. Social Workers meet with each family to assess challenges, and develop a service plan, with a goal of preventing future behavior issues. PAGE aims to support program participants in reaching their highest potential and prevent youth from further involvement in the Juvenile Justice System. Successful completion of the program helps reduce conflict with family, peers and the community.
