On March 1, 2023 at 10:43 AM, the above referenced property was placed under a Notice of Condemnation and Order to Vacate Immediately regarding required repairs or corrections pursuant to Chapter 12 of the Lexington-Fayette Urban County Government Code of Ordinances. The property must be vacated as ordered by end of the date of this notice to avoid any further penalty.

PM-108.5 Chapter 12 of the Lexington-Fayette Urban County Government Code of Ordinances *Prohibited Occupancy*: Any occupied structure condemned by the code official shall be vacated as ordered by the code official. Any person who shall occupy a condemned premises or shall operate placarded equipment, and any owner, owner's authorized agent or person responsible for the premises who shall allow any person or animal occupy a condemned premises or operate placarded equipment shall be liable for the penalties provided by this code.

Exception: This section shall not apply to the owner or the owner's agent when they are actively working to address the status of the property and/or violations of this code, but only when such work is being conducted between the hours of 7:00 a.m. EDT and 10:00 p.m. EDT or authorized otherwise by the code official.

PM-108.5.1 Chapter 12 of the Lexington-Fayette Urban County Government Code of Ordinances Occupying a Condemned Structure: Any property owner who wantonly or intentionally permits any person(s) or animal(s) to inhabit a structure which has been condemned may be issued a civil penalty in the amount of \$250.00 per day. Each day of inhabitation will be considered a separate violation and will only apply after the initial time allotted to vacate the structure has expired.

PM-108.5.2 Any person, who knowingly enters or remains in a condemned structure, not including the exception outlined in PM-108.5, shall be considered in violation of Kentucky Revised Statute 511.080 regardless of their intent or relationship to the premises.

On April 5, 2023 at 11:52 AM, I conducted a re-inspection of the property and found that not all of the cited repairs/corrections have been completed. The purpose of this document is to formally notify you that due to the continued non-compliance and the presence of violation(s) on the property during the above indicated "Date of Issuance", you are being issued a citation. As established in Chapter 12-1 of the Code of Ordinances you have been issued a citation in the amount of \$250.00. This amount includes a \$25.00 Administrative fee.

The property owner may file a written appeal of this action, but must do so within 7 days of the above listed "Date of Issuance". If this citation is not paid within 14 days of its issuance and it is not on appeal, a Notice of Lien Claimed may be filed. If a Notice of Lien is filed, then the property owner will be responsible for all fees and administrative costs associated with the lien as well. Please note that as outlined in Chapter 12-1 of the Code of Ordinances, if the cited repairs are not completed and the property is not brought into compliance before the above indicated "Compliance Due Date", additional penalties ranging between \$100.00 and \$2,500.00 may be assessed.
