ORDER TO SHOW CAUSE

ALLEGED VIOLATIONS:

The Licensee, ABDCO, LLC and Hospitality Management Design, LLC d/b/a Horseshoes KY Grill, at 1987 North Broadway, Lexington, Kentucky 40505 (the licensed premises), is hereby notified that a Field Investigation Report and other documents filed with the Urban County ABC Office contain allegations of the following violation:

1. Violation of KRS 244.080(2): On or about January 6, 2019, for an undetermined period of time, Licensee, an agent, servant or employee thereof sold, gave away or delivered alcoholic beverages to patrons who were apparently or actually under the influence of alcohol, in violation of the statute;

IT IS THEREFORE ORDERED that:

1. Licensee shall appear for a pre-hearing conference, an informal meeting to attempt to resolve or limit the issues involved in this matter, scheduled for **Tuesday, February 19, 2019, at 10:00 a.m.** in the 11th Floor Conference Room of the Government Center, 200 East Main Street, Lexington, Kentucky.
2. Counsel for the Urban County Government will attend the pre-hearing conference and will represent the ABC Office during any administrative hearing(s). *If you do not wish to contest the charges or if you have any questions regarding the process, you may contact Michael R. Sanner in the Department of Law, at (859) 258-*

3500, any time prior to the above date to discuss your case.


